Section 3. Individuals in the above-named appointed positions shall have a satisfactory or above for performance evaluation annually in order to receive the annual pay increase. No performance evaluation is required for elected offices listed above.

Section 4. This Local Law shall take effect in accordance with the Municipal Home Rule Law of the State of New York.
