Section 2: Publication Requirements

Upon the adoption of each local law of the County of St. Lawrence, the Clerk of the Board of Legislators shall cause the publication once in the official newspapers of the County of the notice of the adoption of said local law and an abstract of the provisions thereof. Said notice shall include the location and availability of a copy of the actual text of each local law. This publication shall be in lieu of that required by County Law 214(2), which is hereby expressly superseded by this local law.

Section 3: Effective Date

This local law shall take effect immediately.

ADOPTING LOCAL LAW NO. 4 FOR THE YEAR 1996  
ADOPTING THE RETIREMENT INCENTIVE PROGRAM

NOW, THEREFORE, BE IT RESOLVED that Local Law No. 4 for the Year 1996, A Local Law Adopting the Retirement Incentive Program, is hereby adopted.

PROPOSED LOCAL LAW D (NO. 4) FOR THE YEAR 1996  
A LOCAL LAW ADOPTING THE RETIREMENT INCENTIVE PROGRAM

BE IT ENACTED by the Board of Legislators of the County of St. Lawrence, New York as follows:

Section 1. The County of St. Lawrence hereby elects to provide eligible employees with a retirement incentive program authorized by Chapter 30 of the Laws of 1996.

Section 2. The commencement date of the retirement incentive program shall be October 3, 1996.

Section 3. The open period, during which eligible employees may retire and receive the additional retirement benefit, shall be 90 days in length (last day - December 31, 1996).

Section 4. The actuarial present value of the additional retirement benefits payable pursuant to the provisions of this local law shall be funded over a 5 year period. The amount of the annual payment in each of the five years shall be determined by the Actuary of the New York State Employees' Retirement System, and it shall be paid by the St. Lawrence County Treasurer for each employee who receives the retirement benefit payable under this local law.

Section 5. This local law shall take effect when certified by the New York State Secretary of State and submitted to the New York State Retirement System.
