**PROPOSED LOCAL LAW F FOR THE YEAR 1994
GRANTING ECONOMIC DEVELOPMENT ZONE EXEMPTION
IN THE VILLAGE OF POTSDAM**

BE IT ENACTED by the St. Lawrence County Board of Legislators as follows:

THAT the Village of Potsdam have a Tax Abatement for their Economic Development Zone of:

1. An abatement, as permitted under Section 485e of the Real Property Tax Law, of 100 percent for seven years after completion of a project as defined in the law and further abatements in the eighth, ninth and tenth years of 75 percent, 50 percent, and 25 percent respectively; and
2. A refund or credit of the sales tax on tangible, personal property purchased for use in structuring, rehabilitating, or expanding eligible real property located within the zone.

LOCAL LAW NO. 1 FOR THE YEAR 1994

**A LOCAL LAW PROVIDING FOR THE ESTABLISHMENT OF FEES FOR THE
ST. LAWRENCE COUNTY PROBATION DEPARTMENT**

BE IT ENACTED by the Board of Legislators of the County of St. Lawrence as follows:

Section 1. The St. Lawrence County Director of Probation is hereby authorized and empowered to collect the following fees for custody investigations, visitation investigations and alcohol/drug testing.

The fees to be charged are as follows:

No fee shall be charged in any action in which the St. Lawrence County Department of Social Services is named as Petitioner or Respondent.

Section 2. The procedure for the collection of such fees shall be as prescribed by the appropriate laws of the State and any amendments thereto or as determined by the St. Lawrence County Director of Probation where the State has not enacted procedures.

Section 3. The fees set forth in this Local Law may be amended by resolution of the St. Lawrence County Board of Legislators.

Section 4. That this Local Law shall take effect immediately upon all legal requirements being met.
