AUTHORIZING TITLE IIA 8% SUBCONTRACTS

WHEREAS, Resolution No. 119-94 approved an 8% Contract with the St. Lawrence BOCES, and

WHEREAS, the original Contract was for \$47,865, and

WHEREAS, an additional \$3,936 is available, and

WHEREAS, Sections 123 and 201 of the Job Training Partnership Act provide 8% of all Title IIA funds to be used to compliment State Education programs, and

WHEREAS, the New York State Education Department is responsible for administering the 8% funds, and

WHEREAS, the New York State Education Department has determined that these funds can be used to provide basic skills training, and

WHEREAS, the St. Lawrence BOCES Contract proposal was recommended by a Consortium established under the New York State Education Department 8% guidelines, and

WHEREAS, it has been determined that the 20 clients selected for this basic skills training are in need of a longer period of training,

NOW, THEREFORE, BE IT RESOLVED that the St. Lawrence County Board of Legislators does hereby approve the 8% subcontract totalling \$51,801, and

BE IT FURTHER RESOLVED that the Contract will be extended to June 30, 1995.

**ADOPTING LOCAL LAW NO. 8 FOR THE YEAR 1994
GRANTING ECONOMIC DEVELOPMENT ZONE EXEMPTION
IN THE CITY OF OGDENSBURG**

NOW THEREFORE, BE IT RESOLVED that a Local Law No. 8 for the Year 1994 is hereby adopted.

LOCAL LAW NO. 8 FOR THE YEAR 1994

**GRANTING ECONOMIC DEVELOPMENT ZONE EXEMPTION
IN THE CITY OF OGDENSBURG**

BE IT ENACTED by the St. Lawrence County Board of Legislators, as follows:

THAT the City of Ogdensburg have a Tax Abatement for its Economic Development Zone of:

An Abatement, as permitted under Section 485e of the Real Property Tax Law, of 100 percent for seven years after commencement of construction of a project as defined in that law and further abatements in the eighth, ninth and tenth years of 75 percent, 50 percent and 25 percent respectively and that the abatement so authorized shall be for a term of ten years, notwithstanding that the designation of the zone shall expire before the end of such ten-year term.
