RESOLUTION NO. 143-93

**RESCINDING LOCAL LAW NO. 2 FOR THE YEAR 1993  
AND ADOPTING LOCAL LAW B FOR THE YEAR 1993**

**WHEREAS**, Article 3, Section 26 of the Municipal Home Rule Law allows a Legislative Body to reconsider its action on a Local Law and repeal same, and

WHEREAS, the St. Lawrence County Legislature is desirous of clearing up the confusion the currently exists over legislative districts for the upcoming General Election, and

WHEREAS, the St. Lawrence County Legislature wants to minimize the risks of a legal challenge to the election of a Legislature on November 2, 1993 and assure candidates their election for the statutory term of four years,

NOW, THEREFORE, BE IT RESOLVED that the St. Lawrence County Legislature hereby adopts Local Law B For the Year 1993 on which a Public Hearing was held on April 12, 1993, and which reapportions St. Lawrence County into eleven Legislative Districts to achieve fair and equitable representation in the light of the 1990 Census of Population.

Mr. Luckie made a motion to adopt Resolution No. 143-93, seconded by Mr. Romigh and Mr. Wells.

After a very lengthy discussion, Mr. J. Smith called a point of order on the process of voting.

By a roll call vote, Resolution No. 143-93 was defeated with eight (8) yes votes (Teele, D. Smith, Carey, J. Smith, Lacy, Luckie, Wells, Romigh) and fourteen (14) no votes.

Chairman McFaddin announced that there would be an "Executive Session" at 10:29 p.m. and after a brief recess the "Executive Session" started at 10:38 p.m.

Public Session was reconvened at 11:37 p.m. During the Executive Session, Legislators Wells, Snider, and Ashley left the meeting.
