RESOLUTION NO. 61-92

ADOPTING LOCAL LAW 2 FOR THE YEAR 1992

WHEREAS, Legislative & Judicial Committee is recommending a three year term for the position of Public Defender, and

WHEREAS, a public hearing has been held on Local Law 2,

NOW, THEREFORE, BE IT RESOLVED that Local Law 2 for the year 1992 is hereby adopted.

LOCAL LAW 2 FOR THE YEAR 1992

A LOCAL LAW ESTABLISHING A TERM FOR THE PUBLIC DEFENDER

BE IT ENACTED by the Board of Legislators of the County of St. Lawrence as follows:

Section I. The position of Public Defender shall be an appointment for a three year term.

Section II. This Local Law shall take effect immediately.

RESOLUTION NO. 62-92

ADOPTING LOCAL LAW 3 FOR THE YEAR 1992

WHEREAS, Local Law number 1 for the year 1992 was adopted on January 2, 1992, and

WHEREAS, businesses and merchants have raised some concerns about the difficulty of complying with the law as written, and

WHEREAS, a joint meeting of the Community Services and Agriculture Committees was held to discuss these concerns and changes were proposed for Local Law No. 1 for the year 1992, and

WHEREAS, a public hearing has been held on Local Law 3 for 1992,

NOW, THEREFORE, BE IT RESOLVED that Local Law 3 for the year 1992 is hereby adopted.

Mr. MacLennan made a motion to adopt Resolution No. 62-92, seconded by Mr. McFaddin.

After considerable discussion, Mr. MacLennan called the question to close debate, seconded by Mr. Paquin, and carried by a voice vote.

Resolution No. 62-92 was carried by a roll call vote with nineteen (19) yes votes, two (2) no votes (D. Smith and Romigh) and one (1) Legislator absent (Snider).

Local Law 3 for 1992

AMENDING LOCAL LAW 1 FOR THE YEAR 1992

Be It Enacted that Local Law 1-92 be amended in the following manner:

1. Replace Section Two, A, iv, with the following - "non-prescription drugs, feminine hygiene products, and health aids"
2. Replace Section Three, B, i, with the following - "snack foods such as cakes, gum, candies, chips and nuts offered for sale in single packages and weighing five ounces or less, and cigarettes and tobacco, frozen foods, & publicly advertised items on sale for no longer than seven days.
3. Replace Section Three, B, ii, with the following - "Stock keeping items which are under three cubic inches in size, and weigh less than three ounces, and are priced under one dollar".
4. Add a Section Six as follows:

Section Six: Deferring to State Legislation

If the New York State Legislature enacts an Item Pricing Law it shall supersede this Legislation in all respects and this legislation shall be null and void when the State Legislation takes effect".
