River, then downstream in mid-channel to a point opposite a visual extension of Urban Drive, and then at a right angle from mid-channel to the southern Village boundary near a private loop road.

Section 4: SEPARABILITY OF PROVISIONS

If any clause, sentence, paragraph, subdivision, section or part of this Local Law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment, decree or order shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation of the clause, sentence, paragraph, subdivision, section, or part thereof directly involved in the controversy in which such judgment, decree or order shall have been rendered.

Section 5: CONFLICT WITH PREVIOUS LOCAL LAWS

In the event of a conflict or inconsistency between this Local Law and any previous Local Law or Resolution of this Board of Legislators, this Local Law shall govern.

Section 6: EFFECTIVE DATE

This Local Law shall take effect when all applicable statutory requirements for its passage, adoption and implementation have been complied with fully and it has been duly filed as provided by the Municipal Home Rule Law.

RESOLUTION NO. 184-92

ADOPTING LOCAL LAW NO. 6 1992

LOCAL LAW NO. 6 FOR THE YEAR 1992

A LOCAL LAW ADOPTING THE RETIREMENT INCENTIVE PROGRAM

Be it enacted by the Board of Legislators of the County of St. Lawrence, New York, as follows:

- Section 1. The County of St. Lawrence hereby elects to provide all its eligible employees with a retirement incentive program authorized by Chapter 643 of the Laws of 1992.
- Section 2. The commencement date of the retirement incentive program shall be October 3, 1992.
- Section 3. The open period, during which eligible employees may retire and receive the additional retirement benefit, shall be 90 days in length.
- Section 4. The actuarial present value of the additional retirement benefits payable pursuant to the provisions of this local law shall be funded over a five year period. The amount of the annual payment in each of the five years shall be determined by the Actuary of the New York State Employees' Retirement System, and it shall be paid by the St. Lawrence County Treasurer for each employee who receives the retirement benefit payable under this local law.
- Section 5. This local law shall take effect when certified by the New York State Secretary of State and submitted to the New York State Retirement System.

RESOLUTION NO. 185-92

CREATING A POSITION IN THE CENTRAL SERVICES DEPARTMENT
