**WHEREAS,** in 2020, the Safe Harbour Grant allocation was \$43,350, and of that allotted \$43,350, the breakdown included: \$25,000 to a Youth Advocate Program (YAP) School Based Program and \$18,350 was allotted to additional other fees and services, and

**WHEREAS,** in 2021, St. Lawrence County was approved by Office of Children and Family Services (OCFS) for Safe Harbour Grant Funds of \$40,000, available for use from January 30, 2021 for the twelve (12) month program period and with the reduction of \$3,350, an amendment is required to reflect the decrease in the other fees and services,

# AUTHORIZING A SETTLEMENT AGREEMENT BETWEEN JOHNSON & JOHNSON AND ST. LAWRENCE COUNTY WITH RESPECT TO AN ACTION RELATING TO THE OPIOID CRISIS

**WHEREAS,** St. Lawrence County has the second-highest opioid related-inpatient hospital admissions rate in the State in the past four years, and drug-related hospital stays have risen more than sixty percent (60%) according to the New York State Department of Health, and

**WHEREAS,** New York State Department of Health figures indicate at least thirty-one (31) people have died from opiate or heroin overdoses in St. Lawrence County between 2010 and 2014, and the number appears to be rising, and

**WHEREAS,** in 2017, St. Lawrence County, through its law firm Simmons, Hanly, Conroy, P.C. joined a class action lawsuit with numerous other municipal entities against

Pharmaceutical companies, drug manufacturers and distributors, which included Purdue Pharma, and

**WHEREAS,** Purdue Pharma, Abbott Laboratories, Johnson & Johnson (also known as "J & J" or "Janssen"), as well as others, were alleged to have created damages as a result of the usage and prescription of OxyContin to the general public, and

**WHEREAS,** St. Lawrence County has reached terms of an agreement with Purdue Pharma and has adopted Resolution No. 192-2021, which approved the proposed bankruptcy restructuring plan and authorized a vote in favor of the proposed settlement, and

**WHEREAS**, there remains pending the matter of County of St. Lawrence v. Purdue Pharma L.P., et al., under Index No. 400001/2017 in the Supreme Court, Suffolk County, regarding the opioid addiction crisis, in which the County of St. Lawrence is one of the named plaintiff in the action (the "Action"), and

WHEREAS, the Action alleges several causes of action against defendants Johnson & Johnson, Janssen Pharmaceuticals, Inc., Ortho-McNeil-Janssen Pharmaceuticals, Inc. and Janssen Pharmaceuticals, Inc. ("J & J") based on claims that J & J contributed to the opioid epidemic by falsely promoting prescription opioids it manufactured and sold and by falsely promoting the increased use of opioids directly and generally through various "front groups" and failing to implement measures to prevent diversion of prescription opioids in connection with distribution of its products, all of which contributed to a public health crisis around the United States, and in specific, in St. Lawrence County, and

**WHEREAS,** J & J has offered to settle the claims with the County of St. Lawrence by paying a sum of between approximately \$717,788.65 and \$307,565.44 over ten (10) years to be used for restitution and abatement and agreeing to not manufacture, sell or promote opioids, and

WHEREAS, it is in the best interest of the County of St. Lawrence to resolve this matter with respect to J & J without further litigation and enter into the proposed Agreement as it shall settle all allegations against J & J and avoid protracted litigation,

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Legislators authorizes a settlement agreement between Johnson & Johnson and St. Lawrence County with respect to an action relating to the opioid crisis, retroactive to September 9, 2021, and

**BE IT FURTHER RESOLVED** that the execution and delivery on behalf of and in the name of the County of St. Lawrence by the Chair of the proposed Agreement is authorized, and the Chair is authorized to execute the proposed Agreement in a form substantially similar thereto and execute such other documents as may be necessary and appropriate to effectuate the settlement with J & J, upon approval of the County Attorney.

ADOPTING THE LEGAL ARGUMENTS OF THE AMICUS BRIEF SUBMITTED BY THE STATE OF ARIZONA ON BEHALF OF TWENTY-FIVE SIMILARLY SITUATED STATES IN THE MATTER OF THE NEW YORK STATE RIFLE AND PISTOL ASSOCIATION, INC. ET. AL V. KEVIN P. BRUEN, IN HIS OFFICIAL CAPACITY AS SUPERINTENDENT OF THE NEW YORK STATE POLICE, ET AL. CURRENTLY PENDING BEFORE THE UNITED STATES SUPREME COURT

By Mr. Acres, Chair, Finance Committee Co-Sponsored by Mr. Reagen, District 1; Mr. Lightfoot, District 3; Mr. Sheridan, District 4; Mr. Denesha, District 6; Mr. Perkins, District 7; and Ms. Curran, District 15

**WHEREAS**, the State of New York currently prohibits law-abiding citizens from a carrying a handgun outside the home without a license, and it denies licenses to every citizen who fails to convince the state that he or she has "proper cause" to carry a firearm, pursuant to Penal Law § 400.00, and

**WHEREAS**, it is apparent by the language of the statute regarding the pistol licensing officer that the operative provision of "proper cause" allows a licensing officer to subjectively determine whether a person has the ability to carry a weapon, without regard to right and arguably in violation of the 2<sup>nd</sup> Amendment of the United States Constitution, and

**WHEREAS,** in 2019, the St. Lawrence County Board of Legislators supported the efforts of the State of Louisiana and 17 other states who filed amicus seeking to challenge provisions of the pistol licensing statutes in New York State through the legal action of the New York State Rifle and Pistol Association, Inc. et. al. v. City of New York, State of New York et. al. (hereinafter referred to as 'NYSRPA I'), and

WHEREAS, during the pendency of NYSRPA I, New York State modified the law to permit homeowners who had a premises license to carry to and from their second homes, rendering the legal action moot but leaving the ultimate issue as to the constitutionality of the New York State pistol licensing statutes unresolved, and

**WHEREAS,** the Board of Legislators directed the St. Lawrence County Attorney to remain apprised of any further opportunities to challenge the pistol licensing scheme, whether through legislative change or litigation, that were to arise following the conclusion of NYSRPA I, and

**WHEREAS,** pursuant to that direction, the St. Lawrence County Attorney, as a member of the United States Supreme Court Bar, has reviewed the briefs filed in the matter of New York State Rifle and Pistol Association, Inc. et. al. v. Kevin P. Bruen, In his Official Capacity as Superintendent of the New York State Police et. al (hereinafter referred to as 'NYSRPA II'). currently pending before the United States Supreme Court on grant of petition of certiorari, and

**WHEREAS,** the principle issue before the United State Supreme Court on NYSRPA II is whether the pistol licensing process in the State of New York, by requiring a citizen to demonstrate 'proper cause', violates the 2<sup>nd</sup> Amendment of the United States Constitution, and

**WHEREAS**, the review of the petitions of the respective parties, as well as the amicus briefs, filed by the respective amicus curiae, and

WHEREAS, among the amicus briefs reviewed was a brief filed by the States of Arizona, Missouri, Alabama, Alaska, Florida, Arkansas, Georgia, Idaho, Indiana, Kansas, Kentucky, Louisiana, Mississippi, Montana, Nebraska, New Hampshire, North Dakota, Ohio, Oklahoma, South Carolina, South Dakota, Tennessee, Texas, Utah, West Virginia, and Wyoming (hereinafter referred to as the 'States'), as Amici Curiae, supporting the petition of the New York State Rifle and Pistol Association, and

WHEREAS, the amicus brief filed by the various States through the State of Arizona, has asserted several legal arguments, among them: (1) That Empirical Research and the experience of the majority of the states of the United States of America demonstrates that New York State's restrictive licensing process fails constitutional scrutiny; (2) Shall-issue pistol licensing regimes do not increase crime but do increase victim safety; and (3) That the New York State "proper cause" requirement in Penal Law § 400.00 violates basic protections afforded to the citizens through the Constitutional protections afforded under the 2<sup>nd</sup> Amendment Right to Bear Arms, and

**WHEREAS,** the arguments posited by the State of Arizona (on behalf of the various States) are arguments that the Board of Legislators and many of their constituents of St. Lawrence County share, and

**WHEREAS,** based upon its interpretation of New York State law, the Courts of the State of New York have determined that Penal Law § 400.00 et al. is the "exclusive statutory mechanism for the licensing of firearms in New York State", and

WHEREAS, pursuant to the Penal Law § 400.00(2), "A license for a pistol or revolver, other than an assault weapon or a disguised gun, shall be issued to (a) have and possess in his dwelling by a householder; (b) have and possess in his place of business by a merchant or storekeeper; (c) have and carry concealed while so employed by a messenger employed by a banking institution or express company; (d) have and carry concealed by a justice of the supreme court in the first or second judicial departments, or by a judge of the New York city civil court or the New York city criminal court; (e) have and carry concealed while so employed by a regular employee of an institution of the state, or of any county, city, town or village, under control of a commissioner of correction of the city or any warden, superintendent or head keeper of any state

prison, penitentiary, workhouse, county jail or other institution for the detention of persons convicted or accused of crime or held as witnesses in criminal cases, provided that application is made therefor by such commissioner, warden, superintendent or head keeper; (f) have and carry concealed, without regard to employment or place of possession, by any person when proper cause exists for the issuance thereof...", and

WHEREAS, in New York State, a license to carry a firearm must be issued by the local licensing authority which is defined under Penal Law §265.00 (10), "Licensing officer" means in the city of New York the police commissioner of that city; in the county of Nassau the commissioner of police of that county; in the county of Suffolk the sheriff of that county except in the towns of Babylon, Brookhaven, Huntington, Islip and Smithtown, the commissioner of police of that county; for the purposes of section 400.01 of this chapter the superintendent of state police; and elsewhere in the state a judge or justice of a court of record having his office in the county of issuance, and

**WHEREAS,** the Board of Legislators has long been concerned with the manner in which Pistol Licensing occurs in St. Lawrence County, specifically with respect to the arbitrary and capricious manner in which licenses are issued from County to County within the State of New York, and

**WHEREAS,** in 2008, the Supreme Court of the United States issued the landmark ruling in District of Columbia v. Heller, which announced the Second Amendment protects an individual right to possess a firearm unconnected with service in a militia, and to use that arm for traditionally lawful purposes, such as self-defense within the home, and

**WHEREAS,** the Heller Court held that the individual right to bear arms, as codified in the Constitution, was a pre-existent right, not dependent on the permission of the government, as that right, through codification, "shall not be infringed," and

WHEREAS, despite the clear language of Heller and contemporaneous decision in McDonald v. City of Chicago, Illinois, States such as New York have continued to require its citizens to apply for permission to possess a pistol, rather than start from the operative clause presumption, that the right is fundamental and individual, and may not be restricted in that fashion, and

**WHEREAS,** the State of New York pistol licensing process, as contained in Penal Law §400.00, and as applied by the Licensing Officers listed in Penal Law § 265.00, violates the plain language of Heller and of McDonald, and

WHEREAS, the Board of Legislators, since 2015, has passed a local law and several resolutions seeking to challenge the placement of restrictions by local licensing authorities on the issuance of pistol licenses for pistol license applicants, recognizing the constitutional supremacy of the Heller decision over the legal restrictions imposed by the local licensing authority and licensing scheme established by the State of New York, and

WHEREAS, in light of the Supreme Court of the United States' decision to grant certiorari to the New York State Rifle and Pistol Association, Inc. et. al. v. Kevin P. Bruen, in his Official Capacity as the Superintendent of New York State Police et al. case, the Board of Legislators believes there may be an opportunity to join the action in support of the amicus for the purposes of asserting the rights of the citizen's the Board represents, and

**WHEREAS,** the privileges and immunities of the citizens of the United States of America and of the State of New York are to be ardently protected and secured by the respective governmental bodies of all such bodies, and

**WHEREAS**, the due process of law must be provided to each and every such citizen especially to matters of constitutional and ancient rights and liberties, and

WHEREAS, the ancient right and liberty to keep and bear arms is such a right and liberty, as being specifically recognized and duly adopted by the Second Amendment of the Constitution of the United States deserving to be so fully secured and protected, and

WHEREAS, the Supreme Court of the United States has undertaken to review the lawfulness and validity of the New York State Pistol Licensing process and it being the determination of this representative body being a legislature of the People of St. Lawrence County, State of New York the same being created under the Constitution of the State of New York as ratified by the People of the State of New York that the pistol licensing requirement of a demonstration of 'proper cause' constituting an unlawful and invalid infringement upon the ancient and constitutional right and liberty of the citizens of the United States to keep and bear arms as announced in the Second Amendment of the Constitution of the United States,

**NOW, THEREFORE, BE IT RESOLVED** the Board of Legislators adopts the legal arguments of the amicus brief submitted by the State of Arizona on behalf of twenty-five similarly situated states in the matter of the New York State Rifle and Pistol Association, Inc. et. al. v. Kevin P. Bruen, in his official capacity as Superintendent of the New York State Police, et. al. currently pending before the United States Supreme Court, and

**BE IT FURTHER RESOLVED** that a copy of this resolution shall be forwarded to the State of Arizona Solicitor General for review and support of the Amicus Curiae Brief filed by the State of Arizona on behalf of the various States, and

**BE IT FURTHER RESOLVED** that the St. Lawrence County Attorney shall render aid, where possible and practicable, to the various States listed as Amici Curiae in the pending United States Supreme Court case of the New York Rifle and Pistol Association, Inc. et. al. v. Kevin P. Bruen, in his Official Capacity as Superintendent of the New York State Police, et al.

# SUPPORTING MILFOIL REDUCTION EFFORTS ON SYLVIA LAKE IN THE TOWN OF FOWLER AND MODIFYING THE 2021 BUDGET FOR ST. LAWRENCE COUNTY

By Mr. Acres, Chair, Finance Committee Co-Sponsored by Mr. Sheridan, District 4

**WHEREAS,** invasive species are non-native plants and animals from other parts of the world that can threaten native wildlife and ecosystems causing ecological havoc in some of our most sensitive habitats by pushing many of the native plants and animals to the brink of extinction, and

**WHEREAS**, the negative consequences of invasive species are far-reaching, costing the United States billions of dollars in damages every year, and once invasive species become established and spread, it can be extraordinarily difficult and costly to control or eradicate them, and

**WHEREAS,** the best approach for dealing with invasive species is to create effective mechanisms to prevent their introduction in the first place, create monitoring systems for detecting new infestations, and move rapidly to eradicate newly detected invaders, and

**WHEREAS,** Eurasian water-milfoil has been identified in Sylvia Lake, in the Town of Fowler, and is quickly becoming a problem as it spreads rapidly forming mats of vegetation on the water surface, and these mats interfere with recreational activities such as boating, tourism, fishing, waterfowl hunting, and outdoor recreation, and

**WHEREAS,** Sylvia Lake has 3.9 miles of shoreline and is fed largely by spring waters, and is as deep as 142 feet in the northern lobe and near 70 feet in the southern portion, but parts of the Lake such as the South Short, Inlet Bay and some other areas are much more shallow with muddy floor sediment that provides ideal conditions for thick growth of milfoil, and

**WHEREAS,** the Sylvia Lake Association has tried hard over the years to slow the spread of milfoil on the Lake by utilizing manpower and ingenious post-conventional methodologies, and although a Milfoil Task Force has been formed they feel they are losing the battle in their efforts to smother the invasive weeds, especially near the South East inlet to the Lake, and

**WHEREAS,** the Task Force has had discussions with Eco professionals from Cornell, St. Lawrence, and the NYS DEC with a goal of aquatic invasive management, and a Milfoil Management Fund has been created accepting donations to try to raise the substantial amount of funding needed to manage the invasive species, and

**WHEREAS,** Eurasian water-milfoil can negatively affect the water bodies it invades in several ways due to its tendency to branch profusely and form a dense canopy over the surface of the water shading out native vegetation, along with the creating a good habitat for mosquitoes, and

**WHEREAS**, the plant is not a valuable food source for waterfowl unlike some of the native submersed aquatic plants and the plant biomass can become so dense that predator fish will lose their foraging space and will be less effective at controlling prey species resulting in an imbalance fish community,

**NOW, THEREFORE, BE IT RESOLVED** the Board of Legislators supports milfoil reduction efforts on Sylvia Lake in the Town of Fowler, and

**BE IT FURTHER RESOLVED** that the Treasurer is authorized to modify the 2021 Budget for St. Lawrence County, as follows:

**WHEREAS**, on March 27, 2021, Resolution No. 67-2021 appointed Jolene Munger to the position of Interim Director of Public Health, and

**WHEREAS**, the Search Committee completed a search with the assistance of a recruiter, and recommended that the current Interim Director should remain in the role,

**WHEREAS,** the interim appointment will provide an opportunity for a permanent appointment to be considered by the Board of Legislators and the Board of Health, upon approval of the New York State Department of Health,

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Legislators affirms Jolene Munger to the position of Interim Director of Public Health at a salary of \$101,616 to commence immediately, until a permanent appointment of Director of Public Health for St. Lawrence County, and

**BE IT FURTHER RESOLVED** that the interim appointment for Jolene Munger will increase the salary to Band VII, Step 2, and authorize payout of current compensatory time.

#### **COUNTY ADMINISTRATOR'S REPORT:**

Ms. Doyle said there has been an increase in COVID-19 cases, and she would like to review options for employees whose jobs include going into people's home and interacting with the public to wear masks as an alternative to a full mask mandate. There are ongoing conversations with school districts regarding k-12 testing mandates.

Last week she and Chair Sheridan met with the SUNY Canton Chancellor on a panel to discuss how SUNYs are redefining themselves.

Negotiations for Council 82 Supervisors are scheduled this week.

The County has its reporting in for the American Rescue Plan.

Operations and Services Committees are scheduled for next Monday, and Finance will be held on September 27<sup>th</sup>. DANC will be providing a broadband survey at the Finance Committee Meeting.

NYSAC is working on cyber security challenge, and Ms. Doyle was asked to join an advisory team

Ms. Doyle said there has been an additional \$250 million appropriated for the Emergency Rental Assistance Program (ERAP) and have included landlords so that they are now able to apply. There are 450 applications complete in St. Lawrence County for rental arrears, 364 applications for the prospective rental, and 103 utility arrears applications completed.

St. Lawrence County was awarded for the highest earner award for the procurement card and received \$111,000 in rebates this year. Since this initiative began, St. Lawrence County has consistently been the highest earner. Ms. Doyle gave great thanks to Stephanie Kerr in the Purchasing Department for her efforts.

Ms. Doyle said she and County Treasurer, Renee Cole, graduated from the County Government Institute tonight.

Ms. Terminelli asked how the unions and staff feel about the mask mandate. Ms. Doyle said she will gather the information from staff and unions.

Ms. Haggard said employers with more than 100 employees are now able to mandate vaccines or testing, and she asked if the County fell into this group. Count Attorney Button said President Biden issued an Executive Order on protecting workers health and safety under the Occupation Safety and Health Administration (OSHA). He believes this does not include government

agencies at this time.

#### **OLD/NEW BUSINESS:**

Mr. Perkins said he has concerns of the Parishville EMS responding to calls all over the County because some towns are unable to get nearby departments to respond. This leaves the Parishville area not covered when an emergency arises. Part of the issue may be the lack of volunteers and the stringent training. He has spoken with Emergency Services Director Matt Denner and will follow up with him on solutions.

Ms. Haggard said she understands by being an elected official she is open to having comments made about herself, but the way public participation is being conducted causes her concern. She believes in freedom of speech and believes anyone who wishes to come before the Board should have a right to do so, but comments made about private citizens seems wrong.

Mr. Smithers said at the Town of Gouverneur meeting Community Center has had to expand the meals on wheels and has requested help with funding.

Mr. Burke said he would like an update on the status of the opioid treatment program clinic. He said he believes the provider is in breach of the contract as the clinic is not up and running.

**COMMITTEE REPORTS:** Mr. Smithers said the Gouverneur Fair Board has reported the County fair was very successful this year.

Mr. Perkins moved to go to Executive Session at 9:45 p.m., to discuss litigation, negotiations, personnel, and appointments, seconded by Mr. Smithers and Mr. Denesha, and carried by a voice vote with fourteen (14) yes votes, and one (1) absent (Arquiett).
