LOCAL LAW NO. 9 FOR THE YEAR 1986

REFUNDING PRO-RATED VETERANS EXEMPTIONS ON THE 1986 TAX ROLL
PURSUANT TO SECTION 458 (5) OF THE REAL PROPERTY TAX LAW

Be it enacted by the Board of Legislators of the County of
St. Lawrence as follows:

- Section 1. The value of Veterans' exemptions as listed on the 1986 tax rolls shall be increased as provided in Local Law No. 10 for the year 1985 and pursuant to Section 458 (5) of the Real Property Tax Law.
- Section 2. This increased exemption shall be effective for the 1986 tax year.
- Section 3. Refunds or credits due as a result of these increased exemptions shall be issued as soon as practical after the return of the tax rolls from the towns to the County Treasurer.
- Section 4. Refunds will be paid only upon proof of exemption being presented and approved by the St. Lawrence County Real Property Tax Services Office and after approval of the County Attorney.
- Section 5. This Local Law is not to be construed as having interest accrued to the refund recipients.
- Section 6. This Local Law shall take effect immediately upon the filing of a certified copy in the office of the Secretary of State of the State of New York.
