Mr. Arquiett, Mr. Forsythe, Ms. Curran, Mr. Burke, Mr. Sheridan, Mr. Lightfoot, Mr. Denesha, Mr. Acres and Mr. Perkins asked to be added as a co-sponsors to this resolution.

Mr. Fay left the room at 6:51 p.m.

Mr. Reagen moved to amend the resolution to change the wording in the title of the resolution and in the now, therefore, be it resolved to state "...and to reconsider the decision to close the Ogdensburg Correctional Facility," seconded by Mr. Lightfoot and carried by a voice vote with fourteen (14) yes votes and one (1) absent (Fay).

Motion carried by a voice vote with fourteen (14) yes votes and one (1) absent (Fay).

11. COUNTY ADMINISTRATOR'S REPORT

Ms. Doyle said the County is at a rate of 55.2% fully vaccinated for COVID-19, and there is a 6.37% positivity rate. Three County Departments are impacted at this time with positive cases. The final approval for Pfizer vaccines for 5-11 year olds was approved, and Public Health will hold a clinic at St. Lawrence University on November 13th from 9 a.m. to 4 p.m. at the fieldhouse.

Mr. Fay returned to the room at 6:53 p.m.

There has been work on developing a supplemental plan for Emergency Services. Information is being collected and data pulled together to have a well-informed discussion on a plan going forward. This will be discussed at the Emergency Management Services Committee and then will come to Operations Committee Meeting in December.

On Thursday the offices will be closed in recognition of Veteran's Day. The Court House Tower will be illuminated with green lights for 'Operation Green Light,' which is an initiative the County has taken on to show support for veterans and to raise awareness and let veterans know they are seen, appreciated, and supported. There has been VIP parking spaces placed at the Court House, HB Smith Building, Human Services Center, and Public Safety Complex for veterans.

The Bonadio Group will arrive tomorrow to begin work at the Department of Social Services.

There will be a discussion regarding the pilot program on the move to Ogdensburg at the upcoming Services Committee meeting.

The 2022 Tentative Budget Department Summaries were distributed.

The Department of Social Services will give a brief overview next week at the Services Committee Meeting on the training program for Children's Services.

Ms. Doyle said she met with Legislator Acres, the Chair of the American Rescue Plan Committee, regarding the American Rescue Plan Act (ARPA) and the full Committee will meet soon to begin work. The County has a survey on the website for County residents to offer suggestions on spending the ARPA Funds.

Information will be provided at the November Finance Committee Meeting regarding the Legislative Agenda.
