Ms. Doyle said 207 cases of COVID have been reported through the weekend and today. There has been an increase in testing. 61.1% percentage of citizens are vaccinated in St. Lawrence County. Tomorrow the County will be going out to the farms to administer boosters for farm workers. Pfizer clinics continue at the Public Health Department. Community pods may be held in January. There will be a COVID leadership call tomorrow with NYSAC. The Reopening Task Force will be reconvening to help businesses adhere to the new mandates.

1,174 without power due to the storm on Saturday. 1 family displaced. EMS dispatch worked tirelessly, Sheriff's department, Highway, OFA staff stepped up.

EMS was going to present a plan to the advisory board first. Make amendments before . going to schedule district meetings to present the plan to bring back to the Board in February.

OLD/NEW BUSINESS – Mr. Burke said he spoke with the County Attorney today about removing tax on home heating fuel and it appears there is an extending protocol that has to be done before this can be done. It would be the first of April which would put it past the heating season. Mr. Burke suggested we look for other ways to assist as this does not seem to be expedient.

Mr. Denesha said maybe we could put money towards weatherization. Mr. Reagen said could we ask CDP and DSS and NCHC if money were made available for weatherization to expand the

number of household to get assistance to get an idea of what their capability would be to help more people.

Mr. Acres said the mortality rate is .00925.

Mr. Perkins said we have over 8,000 individuals on HEAP right now, and he thought it would be better to increase the income threshold for the working poor.
