LOCAL LAW NO. 13 FOR THE YEAR 1984

A LOCAL LAW AUTHORIZING ST. LAWRENCE COUNTY TO BECOME A PARTICIPATING MEMBER
OF THE CAPITAL DISTRICT REGIONAL OFF-TRACK BETTING CORPORATION

Be it enacted by the Board of Legislators of the County of St. Lawrence as follows:

Section 1. St. Lawrence County is hereby authorized to participate in the Capital District Off-Track Betting Region Corporation, said corporation to implement an off-track betting system for the Capital District Region following approval of the addition of St. Lawrence County by the New York State Wagering and Racing Corporation.

Section 2. Insofar as the provisions of this law are inconsistent with the provisions of any special or local laws, the provisions of this local law shall be controlling.

Section 3. This local law shall take effect 45 days after adoption or upon approval of a majority of the electors' vote, if a petition for a permissive referendum is filed pursuant to the provisions of Section 24 of the Municipal Home Rule Law.
