LOCAL LAW NO. 4 FOR THE YEAR 1983
A LOCAL LAW ESTABLISHING THE SALARY FOR THE
SUPERINTENDENT OF HIGHWAYS

Be it enacted by the Board of Legislators of the County of St. Lawrence as follows:

Section 1. The annual salary for the Superintendent of Highways shall be \$30,475.00.

Section 2. This local law shall take effect 45 days following its adoption by resolution of the St. Lawrence County Board of Legislators.

Section 3. The full amount of the salary shall be paid during the year 1983.
