ADOPTING LOCAL LAW NO. 12 FOR THE YEAR 1981

WHEREAS, a public hearing has been held on November 30, 1981 regarding Local Law No. 12 for the year 1981, and

WHEREAS, prior notification of such local law was provided to the members of the St. Lawrence County Legislature,

NOW, THEREFORE, BE IT RESOLVED that Local Law No. 12 for the year 1981 is hereby adopted.

Mr. Greco made a motion to adopt resolution number 234-81, seconded by Mr. Hess.

Mr. Smith moved to have the County Clerk receive \$1500.00 this year for the whole 3 years. This motion died for lack of a second.

Mr. Abrams moved to amend Local Law No. 12 to provide for an increase in salary in the County in lieu of \$1500.00, the sum of \$2,000.00, and respectively increasing the same accordingly for the year 1983 to \$24,500.00 and in 1984, \$26,500.00. Seconded by Mr. Marscher.

By a roll call vote on the amendment, the amendment was carried with twelve (12) yes votes, nine (9) no votes as shown below:

LOCAL LAW NO. 12 FOR THE YEAR 1981
A LOCAL LAW INCREASING THE ANNUAL SALARY
FOR THE COUNTY CLERK

Be it enacted by the Board of Legislators of the County of St. Lawrence as follows:

Section 1. The annual salary for the office of County Clerk shall be increased by \$2,000.00, making a total salary of \$22,500.00 for the year 1982.


Section 2. This Local Law shall take effect 45 days following its adoption by resolution of the St. Lawrence County Board of Legislators.

Section 3. This increase in salary shall be paid in equal installments beginning on the effective date of this Local Law through the remainder of the year 1982.

Section 4. The annual salary for the office of the County Clerk beginning January 1, 1983 shall be \$24,500.00.

Section 5. The annual salary for the office of the County Clerk beginning January 1, 1984 shall be \$26,500.00.
