LOCAL LAW NO. 13 FOR THE YEAR 1981  
A LOCAL LAW INCREASING THE ANNUAL SALARY  
FOR THE COUNTY SHERIFF

Be it enacted by the Board of Legislators of the County of St. Lawrence as follows:

Section 1. The annual salary for the office of the County Sheriff shall be increased by \$2,000.00, making a total salary of \$22,500.00 for the year 1982.


Section 2. This Local Law shall take effect 45 days following its adoption by resolution of the St. Lawrence County Board of Legislators.

Section 3. This increase in salary shall be paid in equal installments beginning on the effective date of this Local Law through the remainder of the year 1982.

Section 4. The annual salary for the office of the County Sheriff beginning January 1, 1983 shall be \$24,500.00.

Section 5. The annual salary for the office of the County Sheriff beginning January 1, 1984 shall be \$26,500.00.
