ST. LAWRENCE COUNTY  
LOCAL LAW NO. 10 FOR THE YEAR 1980  
A LOCAL LAW ESTABLISHING THE SALARY FOR THE  
ADMINISTRATIVE ASSISTANT

Be it enacted by the Board of Legislators of the County of St. Lawrence as follows:

**Section 1.** The annual salary for the Administrative Assistant shall be \$29,500.00.

**Section 2.** This Local Law shall take effect 45 days following its adoption by resolution of the St. Lawrence County Board of Legislators.

**Section 3.** The full amount of the salary shall be paid during the year 1980.

**RESOLUTION NO. 158A--80**

**AMENDING THE 1980 BUDGET TO PROVIDE A
