Mr. Cooke questioned if this would cover the 2 new men?

Sheriff Allen said that they began sometime in September.

Mr. Hess asked if it would be possible to insert the date after the Clerk has had time to check the dates?

Chairman Rische asked the members of the Board if they could proceed with the vote and insert the dates when Ms. Brainard gets back?

Mr. Hess then suggested an effective date of April 1st, Dr. Bixby agreed.

Mr. Healey moved for a recess.

Chairman Rische reminded him there was already a motion on the floor and asked the County Attorney which motion takes precedence?

The County Attorney ruled Mr. Healey's motion out of order.

Motion to close debate by Mr. Peters, seconded by Mr. Ruitberg. One *negative* vote, Mr. LaSalle.

Amendment carried with Messrs. Healey and Cook voting *no*.

Mrs. Bradley moved for a suspension of the rules in order to introduce the following resolution, seconded by Dr. Bixby. Motion carried with Mr. Johnson and Mr. Harrington voting *no*.

Mr. Collins advised he had made up the list on the basis of information in the Board of Legislators Office and studying other counties' committee assignments. He stated Committee assignments never have been formally adopted by St. Lawrence County Board of Legislators, and that this Committee section was discussed at length at the last Legislative & Judicial Committee meeting.

Mr. Greco moved the Committee section be deleted from the amendment; this was seconded by Mrs. Bradley.

Chairman Abrams advised that the duties of the committees must be spelled out.

Mr. Healey said that four years ago, the chairmen of the committees were assigned the task.

Mr. Greco said they were never approved by the Board, however.

Mr. Marscher made a motion to close the debate, seconded by Mr. Peters, and this motion was carried unanimously.

Mrs. Bradley then moved to amend that the time for meetings from December through February be 2:00 P.M., seconded by Mr. Healey.

This motion was defeated by a Roll Call Vote with the following results: 9 Yes; 12 No (Messrs. Thompson, Marscher, Lemieux, Peters, Hess, Livingston, Cooke, Bell, LaBaff, Herzog, Abrams, and Hammill); 1 Legislator Absent (Dr. Bixby).
