

A local law ESTABLISHING AN ECONOMIC DEVELOPMENT DEPARTMENT

Be it enacted by the BOARD OF LEGISLATORS of the

- Section 1. An Economic Development Department for the County of St. Lawrence is hereby established.
- Section 2. The Economic Developer shall be appointed by the Board of Legislators.
- Section 3. The term of office for the Economic Developer shall be three years.
- Section 4. The salary for the Economic Developer shall be set by the Board of Legislators.
- Section 5. The duties of the Economic Developer shall be to assume the responsibility for initiating, recommending, promoting and carrying out an action program under established policies and procedures relating to the industrial, wholesale/ distribution, recreational and commercial development of St. Lawrence County, and to perform such other services and duties as may be authorized or prescribed by the Board of Legislators.
- Section 6. This Local Law shall take effect immediately upon the filing of a certified copy in the Office of the Secretary of the State of New York.
