COUNTY OF ST. LAWRENCE

1973

LOCAL LAW No. 1

A local law setting the annual salary for the office of commissioner of jurors.

Became a law February 18, 1973 with the approval of the chairman, no petition protesting. Passed by the local legislative body of the county of St. Lawrence. Filed in the office of the secretary of state February 23, 1973.

*Be it enacted by the board of supervisors of the county of St. Lawrence as follows:*

Section 1. The annual salary for the office of commissioner of jurors shall be grade 24, step D, eight thousand five hundred ninety-seven dollars.

§ 2. This local law shall take effect on the first day of the month immediately following the filing of a certified copy in the office of the secretary of state, and upon approval by the electors or upon the expiration of time for the filing of a petition by said electors.

LOCAL LAW No. 2

A local law setting the annual salary for the office of commissioner of elections.

Became a law February 18, 1973 with the approval of the chairman, no petition protesting. Passed by the local legislative body of the county of St. Lawrence. Filed in the office of the secretary of state February 23, 1973.

*Be it enacted by the board of supervisors of the county of St. Lawrence as follows:*

Section 1. The annual salary for the office of commissioner of elections shall be grade 24, step C, eight thousand one hundred ninety-nine dollars.

§ 2. This local law shall take effect on the first day of the month immediately following the filing of a certified copy in the office of the secretary of state, and upon approval by the electors or upon the expiration of time for the filing of a petition by said electors.

LOCAL LAW No. 3

A local law setting the annual salary for the office of commissioner of social services.

Became a law February 18, 1973 with the approval of the chairman, no petition protesting. Passed by the local legislative body of the county of St. Lawrence. Filed in the office of the secretary of state February 23, 1973.

*Be it enacted by the board of supervisors of the county of St. Lawrence as follows:*

Section 1. The annual salary for the office of commissioner of social services shall be twenty one thousand five hundred dollars.

§ 2. This local law shall take effect on the first day of the month immediately following the filing of a certified copy in the office of the secretary of state, and upon approval by the electors or upon the expiration of time for the filing of a petition by said electors.

LOCAL LAW No. 4

A local law setting the annual salary for the office of county attorney.

Became a law February 18, 1973 with the approval of the chairman, no petition protesting. Passed by the local legislative body of the county of St. Lawrence. Filed in the office of the secretary of state February 23, 1973.

*Be it enacted by the board of supervisors of the county of St. Lawrence as follows:*

Section 1. The annual salary for the office of county attorney shall be grade 24, step B, seven thousand eight hundred twenty-six dollars.

§ 2. This local law shall take effect on the first day of the month immediately following the filing of a certified copy in the office of the secretary of state, and upon approval by the electors or upon the expiration of time for the filing of a petition by said electors.

A local law amending section seven and local law seven by increasing the tax exemption to

Became a law March 19, 1973.

*Be it enacted by the board of supervisors of the county of St. Lawrence as follows:*

Section 1. That the tax exemption shall be one of nineteen hundred dollars.

b. The income tax exemption shall not exceed one hundred dollars for the first month prior to the expiration of the tax exemption in either the first or second year of the tax year.

§ 2. This local law shall take effect on the first day of the month immediately following the filing of a certified copy in the office of the secretary of state, and upon approval by the electors or upon the expiration of time for the filing of a petition by said electors.

A local law regulating the geodetic survey of the county of St. Lawrence.

Became a law August 16, 1973.

*Be it enacted by the board of supervisors of the county of St. Lawrence as follows:*

Section 1. The geodetic survey of the county of St. Lawrence shall be conducted in accordance with the provisions of the act of the legislature of the State of New York, chapter 100 of the laws of 1972, as amended.

§ 2. Text. 1.1. The purpose of this act is to provide for the maintenance of the geodetic survey of the county of St. Lawrence and to provide for the continued use of the same.
