A LOCAL LAW to establish a County Traffic Safety Board for the County of St. Lawrence pursuant to Article 43, Section 1672 of the Vehicle and Traffic Law of the State of New York.

BE IT ENACTED by the Board of Supervisors of the County of St. Lawrence, New York, as follows:

Section 1. A County Traffic Safety Board is hereby established pursuant to Article 43, Section 1672 of the Vehicle and Traffic Law of the State of New York.

Section 2. The membership of said board shall be created in accordance with the provisions of Article 43, Section 1673 of the Vehicle and Traffic Law.

Section 3. This law shall take effect immediately.
