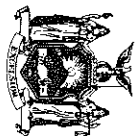

LOCAL LAW NO. 1 -- Year 1966
County of St. Lawrence

A Local Law to provide for the withholding from the salaries and wages of St. Lawrence County employees sums of money sufficient to pay pledges to the United Fund of St. Lawrence County,

Be it enacted by the Board of Supervisors of the County of St. Lawrence as follows:

Section 1. The County Treasurer of the County of St. Lawrence is hereby authorized to deduct from the salaries and wages payable to any St. Lawrence County employee such sums, as have been requested by such employee in writing, as are necessary to make payment of a pledge of said employee to the United Fund of the County of St. Lawrence.

Section 2. Any such pay roll deduction may be discontinued by the filing of a written notice with the County Treasurer.

Section 3. This Local Law shall take effect immediately.
