We would like to invite you to help us with a very important initiative in St. Lawrence County, the “FAVOR” (Find & Assist Veterans of Record) discount ID card program.

Under this program, veterans who file their discharge papers at the County Clerk’s Office are issued a picture ID card, identifying them as an honorably discharged veteran. Participating county merchants agree to honor the card by providing holders with a discount on purchases or services. This program is a way that our county can recognize the service and sacrifices made by our veterans.
