ST. LAWRENCE COUNTY BOARD OF HEALTH MEETING November 15, 2022

The St. Lawrence County Board of Health (hereafter known as SLCBOH) met on Tuesday, November 15, 2022, in the Large Conference Room, Human Services Center, Canton, New York 13617.

CALL TO ORDER

Dr. Andrew Williams, President, called the meeting to order at 6:05 pm.

APPROVAL OF MINUTES

Upon motion by N. Potter, and seconded by K. Acres, the minutes from the October 18, 2022 meeting were approved.

PUBLIC COMMENT

No Public Comment.

<u>SNAP-Ed Fruit and Vegetable Prescription Initiative Presentation</u>: Cassondra Caswell, Cornell Cooperative Extension. Distributed handout showing the history of the program thus far.

- Eligible individuals are primarily adults/older adults (age 13+) who are low income and have nutrition-related chronic diseases where eating healthy would be a benefit.
- They currently partner with some providers who refer their patients with health concerns, but they are looking to bring more providers on board to bring in additional referrals to the program. They are also working with pediatric partners in St. Lawrence County (parent/guardian attends) and planning to connect with the hospitals.
- Education and training on the program will be provided to area providers. Follow up will take place with providers after a year.
- This program is (6) weeks of classes (1-1 ½ hours/up to 12 individuals) (rotate weekly location) includes education and hands on instruction regarding the buying, washing, cooking and storing of fruits/vegetables. Some classes are held at farmers markets in summer (Canton, Ogdensburg, and Gouverneur). There are no fees for vendors.
- Class participants will receive vouchers to buy fruits/vegetables at farmers markets, local farms and now larger grocery stores. Save-A-Lot was a sponsor last year and they are working to bring WalMart, Price Chopper and Aldi on as additional sponsors.
- Participants are eligible only once per year for classes/vouchers. They are able to attend with a spouse/significant other, but they will not receive additional vouchers.
- If transportation is a hardship, the program will assist and coordinate for transportation.
- This program covers (6) counties: Jefferson, Lewis, St. Lawrence, Essex, Franklin and Clinton
- Information is provided in places where SNAP-Ed participants frequent.



Lead Update: Jolene Munger



- (101) lead tests conducted
- (75) on caseload as of November 7, 2022.
- (3) discharges -(1) new case
 - 20 ug/dL 45 ug/dL(1)
 - \circ 8.5 year old.
 - Recent blood test results showed an increase from 27 ug/dL to 31 ug/dL
- 15 ug/dL 20 ug/dL (3)
 - New case. Parents have been contacted and a home assessment with NYSDOH has been conducted.
 - 7 year old. Long history going back to 2018. BLL has steadily dropped and is currently 16 ug/dL as of August.
 - Child has history going back to 7/21/21. There have been repeated attempts to reach parents via phone/letters NYSDOH has also attempted contact.

Lead Update October 2022



We are still anticipating the change in reporting levels. Information was pulled from LeadWeb which is provided by age group, for October, 2022 – we are unable to compare to those who are currently eligible for testing (ages 1 and 2 years). Currently there is a very low percentage of testing taking place.



There was a discussion of barriers to testing (Point of Care), the NYS Public Health Law requiring lead testing, Medicaid mandates for testing ages 1 and 2 years, and the possibility of creating a law for St. Lawrence County to mandate lead testing. It was noted a lead training is being planned for Code Enforcement Officers through the lead grant.

We continue to provide vaccination clinics. We are currently out of Pfizer and low on Moderna vaccine. We have not provided any adult vaccines for October or November thus far and there have been very few for ages 6 months to 5 years. Jolene asked for member's thoughts on ordering the single dose vials of Pfizer 12+ bivalent to share with providers. We are able to order (50) vials at this time. Dr. Terrence and Dr. Williams were interested in this option.

The Imminent threat continues through December, 2022. We currently have (3) COVID-19 grants:

- Our COVID Grant which was used to help purchase a Utility Command Vehicle (UCV) which will be used for migrant vaccination clinics.
- Vaccine Grant which can be used for monkeypox vaccine.
- Schools Grant which is good through July, 2023

Corporate Compliance Training/Public Health Trainings: Jolene has spoken with Jody Wenzel, Risk Manager, regarding trainings that are required to be completed by Board members.
