WHEREAS, since 1937, National Dairy Month has been celebrated in June to recognize the important role of the dairy industry, with this year marking the eighty-third anniversary of National Dairy Month, and

WHEREAS, milk and dairy foods provide health benefits and valuable nutrients, and

WHEREAS, St. Lawrence County dairy farmers produced 879 million pounds of milk in 2018, ranking the County third in the Northeast Milk Marketing Area which extends from New Hampshire to Maryland, and

WHEREAS, May 2019 milk production ranked St. Lawrence County 51st out of the

top 100 dairy counties in the United States, and

WHEREAS, according to the Northeast Statistical Handbook, 274 dairy farms operate in the county, the second highest number of farm operations in the Marketing Area, and

WHEREAS, St. Lawrence County dairy farmers, milk processors and support industries make significant contributions to the region's economy, and

WHEREAS, the value of dairy products in 2017 exceeded \$139 million and accounted for seventy-three percent (73%) of the total value of all agricultural products generated by St. Lawrence County farmers, and

WHEREAS, the annual St. Lawrence County Dairy Princess Parade and Festival, scheduled each year in June, has been postponed due to COVID-19, but the Canton Chamber of Commerce, which sponsors the event, hopes to reschedule the parade and festival for later this summer,

WHEREAS, all children in New York State have the right to be safe and to be raised in an environment that protects them from potential harm, and

WHEREAS, Sudden Unexpected Infant Death Syndrome (SUIDS) is the sudden, unexplained death of an infant under 1 year of age, and

WHEREAS, following the ABCs (<u>A</u>lone on their <u>B</u>acks in a <u>C</u>rib) of Safe Sleep is the best way to prevent a sleep-related infant injury or death, and babies are safest when they sleep alone on their backs in a crib, with a tightly-fitted sheet, and without bumpers, pillows, blankets, or stuffed animals, and

WHEREAS, babies should not co-sleep with parents, siblings, pets, or anyone else, and

WHEREAS, New York State has been a leader in supporting efforts to prevent unsafe sleep deaths by promoting safe sleep environments through early education programs in hospitals and birthing centers and in distributing cribs to local departments of social services and community-backed organizations so that families in need have the resources to provide a safe sleeping environment for their infant, and

WHEREAS, the Regional Child Fatality Review Team is making every effort to bring a visual awareness to the number of infant fatalities related to unsafe sleep, and

WHEREAS, the Regional Child Fatality Team is launching a year-long campaign to encourage safe sleep practices in St. Lawrence County,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators proclaims June as the start of a year-long campaign encouraging safe sleep practices and well child care in St. Lawrence County, and

BE IT FURTHER RESOLVED that the Board of Legislators urges all citizens of St. Lawrence County to direct their attention to this critical issue and to support programs that promote safe sleep environments for infants.

WHEREAS, Resolution No. 490-2019 authorized the Chair to sign a contract with Motorola Solutions for Computer Aided Dispatch (CAD) and Records Management System (RMS) for the Sheriff's Office and Emergency

Services for the period of April 1, 2020 to March 31, 2026, and

WHEREAS, Resolution No. 491-2019 authorized agreements with the Village of Canton, Village of Massena, City of Ogdensburg, Village of Potsdam and Motorola Solutions for the provision of Computer Aided Dispatch and Records Management Services, and

WHEREAS, the new agreements have all been reviewed by the County Attorney and signed by the County, each local police agency (Village of Canton, Village of Massena, City of Ogdensburg and Village of Potsdam), and Motorola Solutions for the Spillman Flex CAD Program, and

WHEREAS, this technology will allow County & local law enforcement and Emergency Services personnel to unify data and work together to ensure public safety, as well as create an opportunity for better communication between departments, and

WHEREAS, by prepaying the maintenance charges for the fiscal years 2020 to 2025, there is a savings to the County, and the State, by way of decreased costs to grants of approximately \$59,975 over a six (6) year period, leaving the County at a lower maintenance rate for a potential contract extension in 2026, and

WHEREAS, in order to satisfy grant requirements and capture savings, the prepaid maintenance of \$338,124 will be booked to a prepaid account in 2020, then each year a prepaid amount of \$67,625 will be charged to the department and the grant expense would be booked (pending availability), eventually reducing the prepaid account to zero in 2025,

WHEREAS, this resolution is to establish cost accounts in order that the County pay the full six (6) year contract costs for the Spillman Flex CAD Program, and to be the pass-through agency for local police agencies, and

WHEREAS, as the host agency St. Lawrence County will provide initial and annual invoice(s) to each Connected Site (local police agencies) for their portion of the software and maintenance costs so the revenue can offset overall costs covered by the initial payment made by the County,

AUTHORIZING THE CHAIR TO SIGN A MEMORANDUM OF UNDERSTANDING AND A CONTRACT WITH THE RURAL LAW CENTER OF NEW YORK FOR INDIGENT APPELLATE REPRESENTATION

WHEREAS, St. Lawrence County currently funds appellate representation for indigent criminal and family court litigants for assignments that come from two sources; the first source is the Appellate Division, Third Department, and the second source is the St. Lawrence County Court Judges, for appeals from local courts to County Court, and

WHEREAS, the Rural Law Center (RLC) of New York is a non-profit, 501 (c) (3), legal services organization that provides legal services to low income New Yorkers residing in rural counties, and

WHEREAS, for the past five years, the RLC has worked in collaboration with the New York State Bar Association's Committee on Courts of Appellate Jurisdiction, as the Committee created a unique Pro Bono Appeals Program that provides attorneys for appellate services in the Third and Fourth Judicial Department which includes work for St. Lawrence County, and WHEREAS, the RLC has experienced appellate attorneys on staff with extensive criminal and family law appellate expertise, and employs experienced appellate support staff capable of providing high quality appellate representation for up to 80 appeals per year at an annual total cost to St. Lawrence County (IA011704 430AC) of \$200,000, and

WHEREAS, the memorandum of understanding is intended to express the basic outline of the terms of a contract between St. Lawrence County and the Rural Law Center to address the methods of case assignments to the RLC, protocols for payments for services provided under the Contract, methods of case reporting, evidence that the RLC is in compliance with general requirements for entities contracting with SLC, including, but not limited to worker's compensation insurance, New York State Disability Benefits, Liability insurance, Unemployment insurance, and attorney malpractice insurance, and liability insurance,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes the Chair to sign a memorandum of understanding and a one year contract (terms: April 1, 2020 – March 31, 2021) with the Rural Law Center of New York for the provision of indigent appellate representation, upon approval of the County Attorney, and

BE IT FURTHER RESOLVED that the memorandum of understanding as follows; St. Lawrence County and the Rural Law Center of New York, Inc. will enter into a contract whereby the RLC will provide appellate representation for 80 appeals taken by indigent litigants who have been approved for representation to be paid by St. Lawrence County, and

BE IT FURTHER RESOLVED that St. Lawrence County will designate an individual to be the administrative contact between the County and the RLC and the RLC will designate a person to be the authorized contact to work with the County to provide quarterly progress reports to the County, and

BE IT FURTHER RESOLVED that St. Lawrence County will pay the Rural Law Center \$200,000 for the provision of appellate services with payments being made in quarterly installments of \$50,000.



WHEREAS, St. Lawrence County and the City of Ogdensburg are parties to a Sales Tax Agreement ("Agreement") concerning the allocation and distribution of money collected from the sales and compensating use taxes covering the period commencing December 1, 2010 and ending November 30, 2020, and

WHEREAS, St. Lawrence County and the City of Ogdensburg have previously negotiated an amendment to the original Agreement ("Amended Agreement") specifying the distribution of revenue from an additional one (1%) percent receipt of sales and compensating use taxes, and

WHEREAS, both the original Agreement and the Amendment Agreement were approved through adopted Resolution Nos. 364-2009 and 63-2013 by the Board of Legislators, and

WHEREAS, the Board of Legislators and the City of Ogdensburg have been engaged in negotiations, as contemplated by the Agreement and Amended Agreement, in an effort to reach a new Agreement concerning the allocation and distribution of money collected from the sales and compensating use taxes covering the period commencing December 1, 2020 and ending November 30, 2030 with the City of Ogdensburg and to distribute the revenue from the sales and compensating use tax, and

WHEREAS, the parties have not yet reached a long term agreement but would like to continuing negotiations, and

WHEREAS, the parties are willing to extend the current agreement until November 30, 2021 to provide the parties additional time to continue negotiations, and

WHEREAS, it is the parties intention to maintain all other terms of the agreement as are currently in place until the expiration of the extension contemplated in this resolution, and

WHEREAS, if by November 30, 2021 the parties fail to reach an agreement concerning the allocation and distribution of monies collected from the sales and compensating use taxes receivables, commencing December 1, 2021 the County reserves all rights and privileges accorded to it under the New York State Tax Law,
