RESOLUTION NO. <u>36-2023</u>

AUTHORIZING THE CHAIR TO SIGN A CONTRACT WITH CLEAR BALLOT GROUP, INC. FOR THE REPLACEMENT OF ABSENTEE COUNTING HARDWARE, SOFTWARE, AND EQUIPMENT AS WELL AS AUDIT HARDWARE AND SOFTWARE IN ORDER TO MEET ABSENTEE AND AUDIT REGULATIONS FOR THE BOARD OF ELECTIONS

WHEREAS, Resolution No. 203-2021 approved the Technology Innovation and Election Resource (TIER) Program Grant funds that became available from the New York State for the Board of Elections for the period beginning April 7, 2021 through January 27, 2023 in the amount of \$95,379, and

WHEREAS, the Clear Ballot Group, Inc. is under State Contract and is the only certified vendor to be utilized to provide replacement of absentee counting hardware, software and equipment as well as audit hardware and software in order to meet absentee and audit regulations for the board of elections, and

WHEREAS, Clear Ballot Group, Inc. is identified as possessing the knowledge, expertise, required software, associated technology, and services to provide a quality solution to the needs of the St. Lawrence County Board of Elections,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes the Chair to sign a contract with Clear Ballot Group, Inc., for the replacement of absentee counting hardware, software, and equipment as well as audit hardware and software in order to meet absentee and audit regulations for the Board Of Elections, upon the approval of the County Attorney.

Ms. Curran moved to adopt Resolution No. 36-2023, seconded by Mr. Denesha and Mr. Gennett, and carried unanimously by a voice vote with fifteen (15) yes votes.

RESOLUTION NO. 37-2023

AUTHORIZING THE CHAIR TO APPROVE AND SIGN A SETTLEMENT AGREEMENT BETWEEN TEVA PHARMACEUTICALS, LTD. AND ST. LAWRENCE COUNTY REGARDING AN ACTION RELATING TO THE OPIOID CRISIS

- **WHEREAS,** in 2017, through its law firm Simmons, Hanly, Conroy, P.C., St. Lawrence County joined a class action lawsuit with numerous other municipal entities against Pharmaceutical companies, drug manufacturers and distributors, which included Purdue Pharma, and
- **WHEREAS,** Purdue Pharma, Abbott Laboratories, Johnson & Johnson (also known as "Janssen"), McKesson Corporation, Cardinal Health, Inc., as well as others, were alleged to have created damages as a result of the usage and prescription of OxyContin to the general public, and
- **WHEREAS,** St. Lawrence County has already reached terms of an agreement with manufacturer Purdue Pharma, and
- WHEREAS, in addition to the settlement reached with Purdue Pharma, St. Lawrence County has already reached terms of an agreement with manufacturer Johnson & Johnson (also known as "Janssen"), McKesson Corporation, Cardinal Health, Inc., AmerisourceBergen Drug Corporation, PSS World Medical, Inc., Kinray, LLC, Bellco Drug Corporation, and American Medical Distributors, Inc. (the "Distributors"), and Allergan Finance, LLC, and
- **WHEREAS**, there is pending the matter of County of Suffolk v. Purdue Pharma L.P., et al., under Index No. 400001/2017 in the Supreme Court, Suffolk County, regarding the opioid addiction crisis, in which the County of St. Lawrence is a named plaintiff in the action (the "Action"), and
- **WHEREAS**, the Action is against several defendants, including manufacturers of opioids, distributors of opioids and chain pharmacies, and
- **WHEREAS,** on July 26, 2022, Teva Pharmaceuticals, LTD. Pharmaceutical, Ltd., a generic drug manufacturer, as well as its subsidiary drug distributor, Anda Inc., announced a \$4.35 billion global opioid settlement agreement, and
- **WHEREAS,** the proposal calls for Teva Pharmaceuticals, LTD. to pay up to \$3.7 Billion in cash over thirteen (13) years globally and provide what Teva Pharmaceuticals, LTD. estimates as \$1.2 Billion worth of the opioid overdose reversal drug naloxone (to be distributed at the federal level), and
- **WHEREAS,** under the proposed agreement Teva Pharmaceuticals, LTD. will be required to pay as much as \$550 million in New York State, depending on the level of participation from other municipal entities statewide, and
- **WHEREAS,** the State of New York, Nassau County, and Suffolk County are already signatories to the Teva Pharmaceuticals, LTD. NY Agreement, and

WHEREAS, most other political subdivisions in the State (including the City of New York) have an opportunity to become a party to the Teva Pharmaceuticals, LTD. NY Agreement by executing the Subdivision Settlement Participation Form and the Sharing Agreements, and

WHEREAS, under the terms of the proposed settlement, and assuming all incentives are met, St. Lawrence County will receive a total of \$690,226.94, with a portion of this money coming from the "Global" fund (consistent with the national global settlement amount), payable over eighteen (18) years, and

WHEREAS, it is in the best interest of the County of St. Lawrence to resolve this matter with respect to Teva Pharmaceuticals, LTD. without further litigation and enter into the proposed Agreement as it shall settle all allegations against Teva Pharmaceuticals, LTD. and avoid protracted litigation,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes the Chair to approve the settlement agreement, and to sign, or have signed by his designee, the agreement between Teva Pharmaceuticals, LTD. and St. Lawrence County regarding an action relating to the opioid crisis, and

BE IT FURTHER RESOLVED that the Board of Legislators authorizes the Chair, or his designee, to execute the proposed Agreement in a form substantially similar thereto and execute such other documents as may be necessary and appropriate to effectuate the settlement with Teva Pharmaceuticals, LTD. and its subsidiaries, upon approval of the County Attorney.

Mr. Gennett moved to adopt Resolution No. 37-2023, seconded by Ms. Curran and Mr. Denesha, and carried unanimously by a voice vote with fifteen (15) yes votes.

Mr. Lightfoot made a motion from the floor to authorize the Chair to sign an agreement with the New York Power Authority to accept funds associated with road impacts from the Smart Path Transmission Project, seconded by Mr. Denesha and Mr. Reagen, and carried by a voice vote with fourteen (14) yes votes, and one (1) abstention (Terminelli).
