ROLL CALL: All Legislators were present, with the exception of Mr. Forsythe. Mr. Sheridan and Mr. Gennett attended remotely. Mr. Sheridan arrived at 6:29 p.m.

Mr. Denesha offered the prayer followed by the Pledge of Allegiance.

APPROVAL OF THE AGENDA: Ms. Curran moved to approve the agenda, seconded by Mr. Denesha, and carried by a voice vote with thirteen (13) yes votes, and two (2) absent (Forsythe and Sheridan).

APPROVAL OF MINUTES: Ms. Curran moved to approve the March 6, 2023, meeting minutes, seconded by Mr. Smithers, and carried by a voice vote with thirteen (13) yes votes, and two (2) absent (Forsythe and Sheridan).

The new City of Ogdensburg Manager, Mohideen Buharie, addressed the Board of Legislators.

COMMUNICATIONS:

- 1. A resolution was received from Cattaraugus County opposing Governor Hochul's New York Housing Compact Proposal and State Government Override of Local Zoning Laws.
- 2. Three resolutions were received from Chemung County: (1) Supporting Senate Bill S2048, "Increasing the volunteer firefighters' and ambulance workers' credit"; (2) Supporting Senate Bill S4237, "Omnibus Emergency Services Volunteer Incentive Act"; and (3) Encouraging NYS Senate and Assembly to Support and Enact an Amendment to Repeal Subpart (2) of the Tax Law §606.
- 3. A resolution was received from Delaware County calling on the Governor of New York State to reconsider Part N of the Article VII Revenue Bill within the 2024 Executive Budget.
- 4. A resolution was received from Franklin County calling on Governor Hochul to Remove Part M of Article VII Revenue Bills from the 2024 Executive Budget.
- 5. Two resolutions were received from Greene County: (1) Asking Governor Hochul and the NYS Public Service Commission to dismiss NYSEG's (electric and gas) rate hike request and to correct the billing problem before rate hikes are considered; and (2) Urging action by New York State Legislators to advocate on behalf of SUNY Community Colleges to increase funding to community colleges in the State Budget.
- 6. Two resolution were received from Madison County: (1) Urging New York State to return Home Rule Authority to localities for the siting of all wind and solar energy systems that was taken away under the accelerated Renewable Energy Growth and Community Benefit Act and regulations under 94C of the Executive Law; and (2) Opposing waste disposal surcharges and requesting an exemption for planning units.

- 7. Five resolution were received from Sullivan County: (1) Opposing proposed NYS Soil & Water Conservation District Law changes; (2) Opposing Governor Hochul's ban of gas stoves and other new fossil fuel heating equipment; (3) Calling on the Governor and Legislature to support Community Colleges, urging them to develop an equitable county chargeback formula, and urging them to take over the cost of health insurance for Community Colleges as they do for four year SUNY schools; (4) Calling on the State to provide funding to counties and county boards of elections for the costs associated with legislative proposals to hire additional election staff and to provide more flexibility with early voting sites; and (5) Calling for the study and reform of New York State Civil Service System to support local government employee recruitment.
- 8. An email was received from Mildred Smith of Clifton Fine in regards to implementing a new system for random drug testing.

WHEREAS, during the month of April events are planned throughout St. Lawrence County to highlight Sexual Assault Awareness Month,

WHEREAS, the St. Lawrence County Hazardous Materials (HAZMAT) Team was created to assist local rescue and fire departments in their response to incidents involving hazardous materials, and

WHEREAS, HAZMAT services were provided by the Ogdensburg Fire Department, at an annual fee of \$18,000, until the contract ended December 31, 2020, and

WHEREAS, since then the St. Lawrence County Office of Emergency Services resumed management and response operations of the HAZMAT Team, and immediately began soliciting volunteers to ensure continued response, and

WHEREAS, it has been recommended that a budget is be created for the HAZMAT Team to continue operations and ensure adequate response, and

WHEREAS, currently, the HAZMAT Team has forty-four (44) volunteer members and owns and operates two (2) trailers; one for entry purposes and one for decontamination, and

WHEREAS, the trailers are owned by St. Lawrence County and were previously stored in Ogdensburg; Resolution No. 43-2023 authorized a lease of space for the trailers to be stored at the Massena International Airport through December 31, 2023, and

WHEREAS, as the HAZMAT Team continues to operate and recruit new members, training costs are required for members to attend the initial 80-hour HAZMAT Technician Training normally offered for a fee in Montour Falls, conferences are needed to stay up-to-date on HAZMAT-related topics, and medical courses required to ensure adequate treatment of those exposed to hazardous materials, and

WHEREAS, repair and maintenance of HAZMAT equipment and trailers are anticipated; for example, hydrostatic testing of SCBA cylinders and repairs to damaged HAZMAT trailer items, and when possible the CNY Consortium will assist, and

WHEREAS, replacement and acquisition of HAZMAT equipment is necessary; such as replacement of personal protective equipment (PPE) suits, replacement of portable containment pools, and acquisition of additional tools and devices,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes the Treasurer to modify the 2023 Budget for the Office of Emergency Services for the St. Lawrence County Hazardous Materials (HAZMAT) Team, as follows:

SETTING THE ALLOCATION ALGORITHM FOR WORKERS' COMPENSATION PLAN PARTICIPANTS FOR 2024, 2025, AND 2026

WHEREAS, St. Lawrence County established a Workers' Compensation Plan for county, city, town and village employees by Local Laws 1 and 2 of 1956, and

WHEREAS, Local Law 3 of 1993 provides that the apportionment algorithm shall be established for three (3) years, and

WHEREAS, the Board of Legislators last set the apportionment formula in 2020 by Resolution No. 121-2020, and

WHEREAS, for the past fifteen (15) years the St. Lawrence County Workers' Compensation Plan has used an algorithm which, in whole or part, uses a three (3) year average of experience as percentages of the allocation, which is currently one-hundred percent (100%) experience and actuarial based, and

WHEREAS, an allocation formula using risk and experience based rating places emphasis on safety in the work place, and

WHEREAS, an allocation formula in which the non-real property factor is based on the plan participants' payroll, employees' job risk categories and experience results in apportioning costs in a manner more closely related to factors generating risk that are in control of the participants,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators sets the allocation algorithm for Worker's Compensation Plan Participants for 2024, 2025, and 2026, and

BE IT FURTHER RESOLVED that for the years 2024, 2025 and 2026, the allocation formula shall be one-hundred percent (100%) risk-payroll experience, and

BE IT FURTHER RESOLVED that the risk-payroll-experience amount shall be calculated as follows: Payroll, excluding payroll for paid firefighters and fire drivers, for each participant shall be aggregated into \$100 units by New York Compensation Insurance Rating Board (NYCIRB) promulgated class code rates then in effect, and the resulting amount shall be adjusted by an experience modifier, which shall be calculated in accordance with generally accepted underwriting principles and, as approved by the County Attorney and the payroll attributable to a participant's paid firefighters, and paid fire drivers and the per capita charges for volunteer firefighters and volunteer rescue squad members shall not be attributed to all plan participants on a pro rate share for purposes of calculating the allocation of cost under this algorithm, and such attribution shall not change or affect the employment relationship of paid personnel of the status of the relation of volunteers to the respective municipal participants, and

WHEREAS, in 2017, St. Lawrence County, through its law firm Simmons, Hanly, Conroy, P.C. joined a class action lawsuit with numerous other municipal entities against Pharmaceutical companies, drug manufacturers and distributors, which included Purdue Pharma, and

WHEREAS, Purdue Pharma, Abbott Laboratories, Johnson & Johnson (also known as "Janssen"), McKesson Corporation, Cardinal Health, Inc., as well as others, were alleged to have created damages as a result of the usage and prescription of Oxycontin to the general public, and

WHEREAS, St. Lawrence County has already reached terms of an agreement with manufacturer Purdue Pharma, and

WHEREAS, in addition to the settlement reached with Purdue Pharma, St. Lawrence County has already reached terms of an agreement with manufacturer Johnson & Johnson (also known as "Janssen"), McKesson Corporation, Cardinal Health, Inc., AmerisourceBergen Drug Corporation, PSS World Medical, Inc., Kinray, LLC, Bellco Drug Corporation, and American Medical Distributors, Inc. (the "Distributors"), Teva Pharmaceuticals, Ltd., and Allergan Finance, LLC, and

WHEREAS, there is pending the matter of County of Suffolk v. Purdue Pharma L.P., et al., under Index No. 400001/2017 in the Supreme Court, Suffolk County, regarding the opioid addiction crisis, in which the County of St. Lawrence is a named plaintiff in the Action (the "Action"), and

WHEREAS, the Action is against several defendants, including manufacturers of opioids, distributors of opioids, and chain pharmacies, and

WHEREAS, the County of St. Lawrence now has the ability to opt-in to settlements with three additional distributors: Walgreens, Walmart, and CVS, and

WHEREAS, Walgreens has agreed to pay to all plaintiffs approximately \$5.7 billion over 15 years, beginning March31, 2023, and ending December 31, 2036, and

WHEREAS, the total amount of payments that the County of St. Lawrence would receive from Walgreens over the fifteen year period would equal \$313,393.54, and

- **WHEREAS,** CVS has agreed to pay all plaintiffs approximately \$5 billion over ten years, beginning June 30, 2023 and ending June 30, 2032, and
- **WHEREAS**, the total amount of payments that the County of St. Lawrence would receive from CVS over the ten year period would equal \$291,935.55, and
- **WHEREAS,** Walmart has agreed to pay approximately \$3 billion over six years from July 15, 2023, to July 15, 2028, and
- **WHEREAS,** the total amount of payments that the County of St. Lawrence would receive from Walmart over the six year period would equal \$184,545.75, and
- **WHEREAS,** the State of New York, Nassau County, and Suffolk County are signatories to the Walgreens-Walmart-CVS NY Agreement, and
- **WHEREAS,** now most other political subdivisions in the State (including the City of New York) have an opportunity to become a party to the Walgreens-Walmart-CVS NY Agreement by executing the Subdivision Settlement Participation Form and the Sharing Agreements, and
- WHEREAS, under the terms of the proposed settlement, and assuming all incentives are met, St. Lawrence County will receive a total of \$690,226.94, with a portion of this money coming from the "Global" fund (consistent with the national global settlement amount), and
- **WHEREAS,** it is in the best interest of the County of St. Lawrence to resolve this matter with respect to Walmart, Walgreens, and CVS without further litigation and enter into the proposed Agreement as it shall settle all allegations against these three defendants and avoid protracted litigation,
- **NOW, THEREFORE, BE IT RESOLVED** that the Board of Legislators authorizes the execution and delivery on behalf of and in the name of the St. Lawrence County by the Chair, or his designee, of the proposed Agreement is hereby authorized, and the Chair, or his designee, is hereby authorized, to execute the proposed Agreement in a form substantially similar thereto and execute such other documents as may be necessary and appropriate to effectuate the settlement with Walmart, Walgreens, and CVS, subject to County Attorney approval.

WHEREAS, over sixty percent (60%) of the value of real estate in the City of Ogdensburg is exempt from taxation, and

WHEREAS, the single largest tax-exempt land holder in the City of Ogdensburg is the State of New York, and

WHEREAS, the State of New York owns thirty percent (30%) (See Attachment A and Map) of the land area in the City of Ogdensburg, and

WHEREAS, the assessed value of New York State's holdings is over \$200,000,000, and

WHEREAS, the State of New York owns over fifty percent (50%) of all the St. Lawrence River waterfront lands in the City of Ogdensburg, and

WHEREAS, these tax exemptions severely hamper the ability of the City to provide governmental services, including public safety, without exceeding its constitutional taxing limit or raising local real property taxes in a city that already has one of the highest combined tax rates in New York State, and

WHEREAS, these exemptions for New York State owned properties exceed \$8,200,000 in lost revenue to the city, county and school district, and multi-millions of more dollars in lost revenue each year due to their underutilized, blighted, and deteriorating conditions, and the fact that they comprise over fifty percent (50%) of the city's valuable St. Lawrence River waterfront, hampering future private sector growth and development, and

WHEREAS, the State of New York makes PILOT payments to other municipalities in the State in recognition of their tax-exempt status, including Albany, New York which receives over \$22 million annually in PILOT payments from the State of New York,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators supports and a request by the City of Ogdensburg and requests favorable consideration of Senate Bill S4810 and Assembly Bill A5276 during the 2023 Legislative Session, and

BE IT FURTHER RESOLVED that these PILOT payments will be earmarked for public safety and other governmental functions in the City of Ogdensburg, services which are presently provided free to the State of New York at local taxpayer expense, and

WHEREAS, effective December 31, 2022 through 2023 for St. Lawrence County, the New York State Minimum Wage hourly rate, is \$14.20 per hour, and

WHEREAS, the annual minimum wage increases for the region in NYS will continue to increase until the hourly rate reaches \$15.00 per hour, and

WHEREAS, effective July 1, 2021, the NYS minimum wage for fast food workers is \$15.00 per hour, and

WHEREAS, it is understood that the NYS Minimum Wage Law does not apply to public employers, however employees of St. Lawrence County are covered by the Federal Minimum Wage which is currently \$7.25 per hour, and

WHEREAS, St. Lawrence County has experienced continuous difficulty with recruitment and retention of Nutrition Services Aides due to competition with higher paying competing employers, and

WHEREAS, St. Lawrence County and CSEA agree that changing the Grade 7 wage scale to reflect more competitive wages would be mutually beneficial for the employees and the County, and

WHEREAS, recommended changes to the CSEA Grade 7 salary matrix would cost approximately \$35,000 for the full 2023 calendar year, and the 2023 CSEA Grade 7 salary matrix would be as follows:

PROCLAIMING THE MONTH OF APRIL AS NATIONAL CHILD ABUSE PREVENTION MONTH

WHEREAS, all children of St. Lawrence County have the right to being raised in a safe and secure environment that prepares for them for a future of opportunity, sadly, child abuse and neglect threaten the lives and health of many of our County's children who are subjected to verbal, sexual, emotional, and physical abuse, exploitation, and neglect, and

WHEREAS, it is essential for communities to create partnerships among families, human service agencies, schools, law enforcement, and businesses that provide supportive resources and reinforce protective measures to ensure the health and well-being of children and families to reduce incidences of child abuse and neglect, and

WHEREAS, providing community-based prevention services to those families can help avoid the on-going need for protective services, law enforcement, the judicial system, foster care, and the treatment of adults recovering from abuse as children, and

WHEREAS, during National Child Abuse Prevention Month, observed each April, all individuals are encouraged to direct their attention to this critical issue and to support programs that promote the safety and security of children; we also take the opportunity to acknowledge the many dedicated caseworkers who devote countless hours to ensuring the welfare and well-being of our children,

RESOLUTION NO. 152-2023 (FAILED)

URGING THE NEW YORK STATE LEGISLATURE ADOPT THE LOCAL JOURNALISM SUSTAINABILITY ACT

WHEREAS, community newspapers have played a vital role in promoting democracy, free speech, and accountability in local government since the founding of the American nation, and

WHEREAS, in this era of declining civic engagement, less participation in local government and rising turmoil in political discourse, the role of local journalism is important to help communities bridge the partisan divides that can paralyze representative government at all levels, and

WHEREAS, technological challenges caused by the rise of the internet, online shopping, and digital advertising have disrupted communities, causing the closure of more than 2,200 local newspapers in the U.S. since 2005, according to the Washington Post, and

WHEREAS, New York's "Local Journalism Sustainability Act" has been proposed in both the New York State Assembly and the New York State Senate to support the essential role local news organizations play in keeping citizens informed about what is happening with their local democracy, and

WHEREAS, the Local Journalism Sustainability Act would provide tax credits to newspaper publishers for local newsroom salaries – fifty percent (50%) the first year, then thirty percent (30%) for the next four (4) years, and the bill would also provide personal income tax credits up to \$250 to encourage readers who subscribe to local news publications, and

WHEREAS, the 2024 proposed state budget already includes \$700 million in film production tax credits through 2034, a \$92.5 million tax credit for New York City musical and theatrical productions through 2025, and \$40 million for the state Council on the Arts, which administers \$100 million in previously allocated funds, and

WHEREAS, locally, North Country Public Radio received more than \$482,000 in government grants in 2020, according to its financial statement,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators urges the State Legislature to adopt the Local Journalism Sustainability Act, and

BE IT FURTHER RESOLVED that certified copies of this resolution be forwarded to Governor Kathy Hochul; Senator Joseph Griffo; Senator Mark Walczyk; Senator Dan Stec; Assemblyman Ken Blankenbush; Assemblyman Billy Jones; Assemblyman Robert Smullen; and Assemblyman Scott Gray.

Mr. Reagen moved to adopt Resolution No. 152-2023, seconded by Ms. Curran, and failed by a roll call vote with five (5) yes votes (Fay, Haggard, Webster, Curran, Reagen), nine (9) no votes, and one (1) absent (Forsythe).

RESOLUTION NO. <u>153-2023</u>

AUTHORIZING THE CHAIR TO SIGN A CONTRACT WITH THE RURAL LAW CENTER OF NEW YORK FOR INDIGENT APPELLATE REPRESENTATION

WHEREAS, St. Lawrence County currently funds appellate representation for indigent criminal and family court litigants for assignments from the Appellate Division, Third Department, and the St. Lawrence County Court Judges, for appeals from local courts to County Court, and

WHEREAS, the Rural Law Center (RLC) of New York is a non-profit, 501 (c) (3), legal services organization that provides legal services to low income New Yorkers residing in rural counties, and

WHEREAS, since 2014, the RLC has worked in collaboration with the New York State Bar Association's Committee on Courts of Appellate Jurisdiction, as the Committee created a unique Pro Bono Appeals Program that provides attorneys for appellate services in the Third and Fourth Judicial Department which includes work for St. Lawrence County, and

WHEREAS, Resolution No. 81-2014 established the relationship with the RLC and Resolution Nos. 161-2017, 123-2019, and 126-2022 authorized the continuation of their work at varying amounts conscious of the change in caseloads, and

WHEREAS, the RLC has experienced appellate attorneys on staff with extensive criminal and family law appellate expertise, and employs experienced appellate support staff capable of providing high quality appellate representation for up to 60 appeals per year at an annual total cost to St. Lawrence County (IA011704 430AC) of \$180,000 which represents no change in cost from 2022,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes the Chair to sign a contract with the Rural Law Center of New York for the provision of indigent appellate representation from April 1, 2023 through March 31, 2024, upon approval of the County Attorney, and

BE IT FURTHER RESOLVED that St. Lawrence County will pay the Rural Law Center \$180,000 for the provision of appellate services, with payments being made in quarterly installments of \$45,000 with quarterly work reports continuing to be provided to the County Administrator, and

BE IT FURTHER RESOLVED that additional appellate work above the sixty (60) appeals will be paid at \$3,500 per additional appeal, and

BE IT FURTHER RESOLVED that the contract be retroactive to April 1, 2023 upon adoption of the resolution.

Ms. Curran moved to adopt Resolution No. 153-2023, seconded by Mr. Fay, and carried by a voice vote with fourteen (14) yes votes, and one (1) absent (Forsythe).

COUNTY ADMINISTRATOR'S REPORT: Ms. Doyle said the Unified Command Vehicle and Community Services Mobile Clinic Vehicle were on site tonight for Legislators to tour.

The Department of Social Services created a new unit to combat homelessness and have been working on this over the past two (2) months. To date, twelve (12) individuals have been moved to permanent housing which is about an eighteen percent (18%) reduction in the homeless numbers.

St. Lawrence County is well ahead of the State average regarding safety assessments, and have officially hit one-hundred percent (100%) of the required 122 safety checks required for the month of February in Social Services.

The fiscal position in Social Services has been vacant for over a year. New strategies for this position will be discussed tomorrow at the Vacancy Review Committee.

The Vacancy Review Committee will meet tomorrow to discuss and consider seven (7) positions.

Jeffrey Beri, founder of "No Dogs Left Behind," will attend the Services Committee meeting on April 17th to discuss his operation and answer any questions the Board may have.

Trail permits for the Multi-Use Trails will be available for purchase at partner locations on April 7th and can be bought online beginning April 14th.

Ms. Doyle said staff and interested Legislators will be attending an update from NYPA regarding the Smart Path Project.

Ms. Doyle said she will be away and will not attend the upcoming Operations Committee.

The Sales Tax Extender has not yet been resubmitted as there is not a matching Assembly Bill number. Once the new Bills are introduced, a Special Board Meeting will be held and necessary paperwork sent to the State.

Mr. Reagen said the St. Lawrence County IDA has issued their annual report with copies sent to each Legislator.
