WHEREAS, the challenges of pharmaceutical prices rising, along with not being able to predict the population of the jail and medications that may be needed throughout the year, makes establishing an annual budget difficult,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes the Treasurer to modify the 2023 Budget for the Sheriff's Office for prescription costs at the Correctional Facility, as follows:

Mr. Lightfoot said the last two resolution cost nearly a million dollar and are another mandated program from the State of New York.

Ms. Curran said the reason the County is paying for these costs of prescriptions is that when someone is arrested and remanded to the County Jail, their Medicaid coverage, which is State funded, is removed and the County has to cover the cost of all medical services.

Resolution No. 158-2023 was carried by a roll call vote with thirteen (13) yes votes, and two (2) no votes (Perkins and Webster).

CALLING ON GOVERNOR HOCHUL AND NEW YORK STATE LAWMAKERS TO REVERSE COURSE AND RESTORE BIOMASS AS AN IMPORTANT RENEWABLE ENERGY SOURCE TO STRENGTHEN THE ECONOMY AND ENCOURAGE LAND STEWARDSHIP AND RESPONSIBLE FORESTRY PRACTICES

By Ms. Curran, Chair, Operations Committee Co-Sponsored by Mr. Sheridan, District 4; Mr. Smithers, District 5; Mr. Denesha, District 6; Mr. Perkins, District 7; and Mr. Hull, District 8

WHEREAS, the cogeneration plant located on Fort Drum has provided an estimated three hundred (300) jobs across Northern New York to loggers, truck drivers, landowners, saw mill operators and others involved in the forest products industry, and

WHEREAS, due to the failure to recognize the benefits of biomass and forestry industry of the Empire State by Governor Hochul, the Public Service Commission, and leadership of the New York State Senate and Assembly, the plant is being forced to close, and

WHEREAS, the closure will cut off Fort Drum and the 10th Mountain Division, the largest single site employer in New York, from a reliable on-post electrical generating plant that supplies one-hundred percent (100%) of its energy needs, and

WHEREAS, closing the plant will make Fort Drum dependent on less secure energy sources that could be jeopardized by cyber-attacks, sabotage, natural disasters, and major weather events, and

WHEREAS, the loss of three-hundred direct and indirect forestry industry jobs will impact eighty (80) North Country businesses and cost the region an estimated \$25 million that will have a multiplier effect on the economy across the region, and

WHEREAS, forestry owners, farmers, land owners, saw mills, wood pellet companies, local governments, and others will also be negatively affected by the closure of the plant, and is just the latest example of how poorly thought out and ill-conceived the energy policies of New York are hurting working class citizens, reducing the availability of good paying jobs, increasing the price of electricity, and contributing to New York State being the worst place to do business in the nation,

NOW, THEREFORE, BE IT RESOLVED the Board of Legislators calls on Governor Hochul and New York State lawmakers to reverse course and restore biomass as an important renewable energy source to strengthen the economy and encourage land stewardship and responsible forestry practices, and

BE IT FURTHER RESOLVED that certified copies of this resolution be forwarded to Governor Hochul; U.S. Senator Charles Schumer; U.S. Senator Kirsten Gillibrand; Congresswoman Elise Stefanik; Congresswoman Claudia Tenney; Senator Joseph Griffo; Senator Mark Walczyk; Senator Dan Stec; Assemblyman Ken Blankenbush; Assemblyman Billy Jones; Assemblyman Robert Smullen; Assemblyman Scott Gray, New York Forest Owners Association, Empire State Forest Products Association, New York State Association of Counties, New York State Association of Towns, and all counties of New York State.

Ms. Curran moved to adopt Resolution No. 159-2023, seconded by Mr. Reagen, Mr. Hull, Mr. Webster, Mr. Gennett, Mr. Denesha, Mr. Perkins and Mr. Lightfoot.

Mr. Hull asked to be added as a co-sponsor to this resolution.

Mr. Denesha said the legislation makes no sense.

Mr. Reagen said it is a travesty to jeopardize the economy of St. Lawrence and Jefferson counties at a time like this for no apparent reason. Many families in St. Lawrence County involved in the forest industry are going to be harmed by this legislation. Forests are renewable resources, and that is not understood by people from the City.

Ms. Curran said the taxpayer will not benefit from this and may even be put in peril by this legislation.

Ms. Haggard said biomass power plants emit 150% of the carbon dioxide (CO2) of coal and between 300% - 400% percent of the CO2 of natural gas.

Mr. Webster said employees will be losing their jobs and this will affect the taxpayers. Many small villages are worried about where they will now pile their brush and fallen trees. It was picked up at no cost to them, and now there will be nowhere to take it.

Mr. Sheridan asked to be added as a co-sponsor to this resolution.

Resolution No. 159-2023 was adopted by a voice vote with fourteen (14) yes votes and one (1) no vote (Haggard).

APPROVAL OF PAYMENT IN LIEU OF TAXES AGREEMENT IN RELATION TO SOLAR PROJECT ON PARCEL 40.004-2-20.22/1 LOCATED AT 50 COGSWELL CORNERS ROAD IN THE TOWN OF MADRID

WHEREAS, Acer Solar, LLC (the "Company") intends to build and operate a solar energy system as defined by the New York State Real Property Tax Law Section 487 (the "Project") located at 50 Cogswell Corners Road in the Town of Madrid (Tax Parcel No. 40.004-2-20.22), and

WHEREAS, for those Taxing Jurisdictions that have not opted out of RPTL Section 487; pursuant to RPTL Section 487(9) (a), such a taxing jurisdiction could indicate its intent to require a PILOT Agreement with the developer, under which the developer (or any successor owner of the Project) will be required to make annual payments to the Taxing Jurisdiction for each year during the term of the PILOT Agreement, and

WHEREAS, the St. Lawrence County Industrial Development Agency manages the PILOT negotiation process for St. Lawrence County with developers of such solar energy systems, and

WHEREAS, the Company seeks to enter into a payment in lieu of tax agreement with St. Lawrence County pursuant to the following terms:

- Fifteen-year payment in lieu of tax agreement pursuant to Real Property Tax Law Section 487,
- \$5,000 per MW payment to the effected jurisdictions, increasing 2% annually during the term of the agreement; and distributed to St. Lawrence County, Madrid-Waddington School and Town of Madrid based on their pro-rata property tax Distribution, and

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators approves payment in lieu of taxes agreement in relation to solar project on parcel 40.004-2-20.22/1, located at 50 Cogswell Corners Road in the Town of Madrid, and

BE IT FUTHER RESOLVED that the Board of Legislators authorized the Industrial Development Agency to finalize the execution of payment in lieu of tax agreement for the County pursuant to the terms set forth and to administer the billing and collection for the County for the term of the PILOT, upon approval of the County Attorney.

RESOLUTION NO. 182-2023

OPPOSING THE "NEW YORK HOUSING COMPACT" AS PROPOSED IN GOVERNOR HOCHUL'S FY2024 EXECUTIVE BUDGET

WHEREAS, the FY 2024 Executive Budget includes the "New York Housing Compact", and

WHEREAS, the New York Housing Compact consists of the "New Homes Targets and Fast-Track Approval Act" and the "Transit-Oriented Development Act of 2023", and

WHEREAS, the aforementioned Bills are Article 7 Bills in the NYS 2023/2024 budget which due to their inclusion as such eliminates proper legislative process that will make for better legislation, and

WHEREAS, the housing issues outlined in the Bill are not of statewide concern and are focused on New York City and the surrounding suburbs and do not meet the level allowing the State to remove Home Rule of zoning, and

WHEREAS, the Governor claims that the "New Homes Targets and Fast-Track Approval Act" is necessary in order to forestall restrictive land use practices that inhibit and limit housing Development, and

WHEREAS, as proposed the "New Homes Targets and Fast-Track Approval Act" amends General Municipal Law and overrides the local town land use regulations as adopted in the town zoning codes around the State of New York, and

WHEREAS, the "New Homes Targets and Fast-Track Approval Act" requires a Town to meet or exceed a Residential Dwelling Growth Target or enact by local law two of five "preferred actions" in order to be considered in "Safe Harbor" status, and

WHEREAS, all town services, such as police, volunteer emergency services, and/or the school community services would be grossly impacted, and

WHEREAS, under the proposal, appeals can be brought to a new State Housing Review Board usurping the Home Rule authority of local land use boards who understand the local community, and

WHEREAS, the new amended Town Law, as proposed by the Governor would require certain new zoning to be exempt from SEQRA review which would potentially adversely impact the water quality including but not limited to; impacts on traffic and roads, potential impacts on storm water, impact due to building on steep slopes, impact on volunteer emergency services, impacts on police department staffing, impact of additional school age students and the schools

ability to absorb them, increase of sidewalk and mobility connectivity and all standard evaluation criteria typically provided in a generic environmental impact statement, and

WHEREAS, the new amended town law would prohibit municipalities from adopting reasonable and appropriate development regulations to insure the development is compatible with the surrounding uses, such as lot coverage, open space, building height, setbacks, floor area ratios or parking requirements, and

WHEREAS, the residents of the St. Lawrence County have had a voice and participated in land use decisions for decades, from the updating of the various Comprehensive Plans in towns to participating in public hearings and volunteering on town boards and committees, and

WHEREAS, should this proposal by the Governor survive budget negotiations, the residents of St. Lawrence County will be disenfranchised from their local elected officials, local volunteer boards and render certain resident input meaningless,

NOW THEREFORE BE IT RESOLVED that the Board of Legislators opposes the "New York Housing Compact" as proposed in Governor Hochul's FY2024 Executive Budget, and

BE IT FURTHER RESOLVED that the Board of Legislators implores the New York State Legislature to continue to fight against the inclusion of the Housing Compact proposal from the FY 2023/2024 Budget, and future budgets, and engage local Governments in dialogue and address these goals, and

BE IT FURTHER RESOLVED that certified copies of this resolution be forwarded to Governor Kathy Hochul; Senator Joseph Griffo; Senator Mark Walczyk; Senator Dan Stec; Assemblyman Ken Blankenbush; Assemblyman Billy Jones; Assemblyman Robert Smullen; and Assemblyman Scott Gray.
