3. Has been working on AEM planning, soil sampling, cover crop plans, and CMNP Plans. Have 5 more people for cover crops.

4. BMP evaluation for tier 4 projects at Zufall to meet performance measures.

D. Foresters Report- Aaron Barrigar/Heidi Knafelc

1. Been working on county roadway ash/hazard tree removal program. As of today they have marked 3,943 trees, Lisbon, Waddington, Madrid, Massena, and Lousiville.

2. Getting bid together and mapping for the ash/hazard tree program hopes to have it done and out by the end of September.

- 3. Marking parcel 21 for pre commercial treatment.
- 4. Assisting village of Potsdam for urban grant and tree plant application.
- 5. Assisting village of Canton for tree maintenance grant.

6. Biocontrol releases, with APHIS wasp releases to help control the EAB populations, just doing 1 release.
