WHEREAS, in accordance with NFPA 1033 Section 4.7.1, investigators shall prepare written reports; give investigative findings so that the report accurately reflects the facts, data, and scientific principles on which the investigator relied; clearly identify and express the opinion and conclusion of the investigator; and contain the reasoning by which each opinion or conclusion was reached in order to meet the requirement of the intended audience(s), and

**WHEREAS,** to better meet the data-gathering and report-writing requirements, fire investigation case management software was sought to assist in constructing in-depth, intricate, and detailed fire and explosion investigation reports, and

**WHEREAS,** Blazestack, Inc. offers an all-in-one case management solution that assists in data gathering, photography, on-scene documentation, and final report generation, and

**WHEREAS,** the annual cost for Blazestack, Inc., software solutions is \$2,900 for ten (10) investigators,

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Legislators authorizes the Chair to sign a contract, and any other subsequent annual renewal and/or expansion contracts if additional investigators are added to the team, with Blazestack, Inc. for fire investigation case management software, upon approval of the County Attorney, and

**WHEREAS,** as part of the 2023 Interoperability Tower Project the Board of Legislators would like to authorize the construction of new telecommunication towers in the Cranberry Lake Fire District, the Town of Fine, and the Village of Potsdam in order to enhance emergency communications throughout the County, and

**WHEREAS,** one goal of the County is to have an intermunicipal agreement with the Cranberry Lake Fire District, the Town of Fine, and the Village of Potsdam, and award contracts for the design and fabrication of these towers in Potsdam, Fine, and Cranberry Lake, and

**WHEREAS,** the acquisition of land and award of contracts constitutes an "action" as delineated in 6 NYCRR Part 617 and requires that the County comply with the requirements of the New York State Environmental Quality Review Act (SEQRA), and

**WHEREAS,** long Environmental Assessment Forms (EAF) identifying and assessing the potential adverse environmental impacts associated with the proposed construction at each of these three sites have been prepared and distributed in an electronic version to the members of the Board of Legislators for review, and

**WHEREAS**, the preparation of the EAF incorporated data was collected from the following sources: NYS Department of Environmental Conservation critical habitats databases, NYS Office of Parks, Recreation and Historic Preservation information on archeological sites and concerns, FEMA FIRM maps for each town, state and federal wetlands delineation maps, a

state and federal wetland delineation study, internal engineering assessments, radio telemetry studies, a phase-1 environmental audit of the site, highway sufficiency ratings, soil maps and soil boring data, a site survey and assessment of local land use regulations and design considerations that may be incorporated to minimize adverse impacts, and

**WHEREAS**, the County determined that there are no other "involved" agencies as defined in § 617.6 (b) (4),

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Legislators authorizes the Chair to sign an Intermunicipal Agreement with the Cranberry Lake Fire District, the Town of Fine, and the Village of Potsdam for sites to construct interoperability towers in each location, upon approval of the County Attorney, and

**BE IT FURTHER RESOLVED** that based upon the environmental assessment and supporting materials, the Board of Legislators has determined that the development of these projects will not result in any significant adverse environmental impacts related specifically to the construction of the towers occurring after February 6th and that such towers specifically be "non-guyed" and less than 200' in height to minimize impact, all conditions which are consistent with planned actions and activities, and

**BE IT FURTHER RESOLVED** that the Board of Legislators expects to fully comply with any and all permit conditions during construction and occupancy of the building, as may be required.

**WHEREAS,** Human Resources employs Examination Monitors and Chief Exam Monitors to proctor New York civil service exams, and

WHEREAS, these titles are categorized as "flat rate", non-union, per diem positions, and

**WHEREAS,** it is understood that the annual hourly wage rate increases of Exam Monitors mirror CSEA negotiated annual wage increases, and

**WHEREAS,** the 2023 hourly rate for an Examination Monitor is currently \$13.78/hour, and

**WHEREAS,** the 2023 New York State minimum wage hourly rates for Upstate New York is \$14.20/hour, and the New York State minimum wage law does not apply to public agencies, but rather employees of St. Lawrence County are covered by the Federal minimum wage which is currently \$7.25/hour, and

**WHEREAS,** St. Lawrence County recognizes the importance of providing competitive wages to retain current employees and recruit new employees for positions, and

**WHEREAS,** Human Resources recommends changes to the Examination Monitor hourly rate for the remainder of 2023 will cost approximately seventy dollars (\$70) (CP014301 19000),

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Legislators authorizes the hourly rate changes for Examination Monitors to proctor civil service exams for 2023 and 2024, and

**BE IT FURTHER RESOLVED** the hourly wage rate for Examination Monitors be equivalent to the New York State hourly rate of \$14.20/hour or the current rate for Upstate New York, and

**BE IT FURTHER RESOLVED** that the wage increase will go into effect at the beginning of the next full pay period after the date this resolution is adopted by the Board of Legislators.

**WHEREAS,** Human Resources oversees benefit administration for the St. Lawrence County Health Insurance and Pharmacy Plans, and

**WHEREAS,** the benefit advisor for St. Lawrence County is tasked to remain current with trends in the market and bring recommendations to the Healthcare Committee that would benefit the County workforce and improve the ability of the County to provide care, and it is the recommendation of Burnham Benefit Advisors that the County contract with "Allsup" for Medicare coordination, and

**WHEREAS,** Allsup will provide services that includes identifying pre-65 year old retirees or dependents that are disabled and Medicare eligible and converting their health insurance coverage to Medicare as primary coverage, and will also provide the following services:

- Identify qualified plan participants who are entitled to Medicare as primary coverage.
- Monitor disabled plan participants who will become entitled to Medicare in the future.
- Enroll disabled plan participants in Medicare Part B without penalty under federal Disability Special Enrollment Period provisions.
- Represent disabled plan participants for Social Security (SS) Disability Insurance benefits which results in additional benefits for the retiree including Medicare eligibility, increased SS retirement benefits.
- Resolve Centers for Medicare & Medicaid Services Demand Notices requiring reimbursement for charges allegedly paid by Medicare as Primary Payer in error.

**WHEREAS,** by converting Medicare to primary coverage St. Lawrence County can reduce future group health plan expenditures for that member by approximately seventy-one percent (71%), and

**WHEREAS**, Allsup will charge a one-time fee of \$3,000 per Medicare eligible conversion (T5090608-860AD), and

**WHEREAS,** the Company seeks to enter into a payment in lieu of tax agreement with St. Lawrence County pursuant to the following terms:

• Fifteen-year payment in lieu of tax agreement pursuant to Real Property Tax Law Section 487

• \$5,000 per MW payment to the affected jurisdictions, increasing two percent (2%) annually during the term of the agreement billed in reverse order starting with the highest payment in year one; and distributed to St. Lawrence County, Canton Central School District, and Town of Canton based on their pro-rata property tax distribution, and

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Legislators approves payment in lieu of taxes agreement in relation to a solar project on parcel 74.003-2-8./1, located at 6578 County Route 27 in the Town of Canton, and

### OPPOSING THE "ALL ELECTRIC BUILDING ACT" AS INCLUDED IN THE 2024 NEW YORK STATE BUDGET

By Mr. Gennett, Chair, Finance Committee Co-Sponsored by Mr. Sheridan, District 4; Mr. Smithers, District 5; Mr. Denesha, District 6; Mr. Perkins, District 7; Mr. Hull, District 8; Mr. Webster, District 11; and Ms. Curran, District 15

**WHEREAS,** as part of the \$229 billion State budget agreement, New York State became the first State in the Country to ban the use of natural gas and other fossil fuels in new homes and buildings slated to begin as early as 2026, and

WHEREAS, natural gas in widely used in the United States, and according to 2020 data from the U.S. Department of Energy, sixty-one percent (61%) of American households used natural gas for either space heating, water heating or cooking in 2020, and that number is higher in the Northeast where sixty-seven percent (67%) of homes use gas, including fifty-two percent (52%) in New York State, and

**WHEREAS,** according to the American Gas Association, the direct use of natural gas in ninety-two percent (92%) efficient from production to customers which underscores how important it is to look at how energy is produced and delivered when looking to define energy efficiency, and

**WHEREAS,** natural gas plays a critical role in ensuring Americans have access to affordable and reliable energy, and consumers should have the choice to use this abundant fuel source for their appliances, and

**WHEREAS,** in Upstate New York, where power outages often occur during winter snow storms, ice storms, and wind, this ban is anticipated to put households at risk by not having heating or cooking sources available during emergency situation, and forcing citizens to rely on unreliable sources of power, and

**WHEREAS**, there are legitimate concerns this ban may cause a tremendous strain on the electric grid, as well as driving up utility and construction costs,

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Legislators opposed the "All Electric Building Act" as included in the 2024 New York State Budget, and

**BE IT FURTHER RESOLVED** that certified copies of this resolution be forwarded to Governor Kathy Hochul; Senator Mark Walczyk; Senator Dan Stec; Assemblyman Ken Blankenbush; and Assemblyman Scott Gray.

Mr. Gennett moved to adopt Resolution No. 248-2023, seconded by Mr. Smithers, Ms. Curran, and Mr. Lightfoot.

Mr. Denesha said this Board passed a resolution in September requesting no action be taken to reduce or ban any energy sources until reliable energy sources, that have been proven safe and affordable, are in place. In June of 2022 a study was done with the results of the study estimating that the total cost of a typical gas-powered single family home in New York State ranges from 17,400 to \$31,700 and medium household income in St. Lawrence County is \$54,351. He said it is his opinion that the administration in Albany is bent on promoting green energy regardless of the costs to those affected.

Ms. Curran asked to be added as a co-sponsor to this resolution, and said it is a bad idea for Albany to push all electric energy and then talk about shutting down the co-generation plants that produces electrical energy.

Mr. Reagen said this is war on the poor and middle class. If this bill passes, working men and women in New York State are going to be asked to spend tens of thousands of dollars to retrofit their homes for all electric at a time when people are already struggling to just pay basic costs of living. The State of New York needs to think about what it can do to improve living in New York State, not to make it more difficult. Even though the State may have had the best intentions with this bill, it is not going to achieve the goals; It will only create more hardship on families who are already struggling.

Ms. Haggard said this resolution has quite a few caveats, and is an attempt to lower methane gas. It is not as draconian as described and she said she will not support the resolution.

Mr. Smithers said this is another example of a mandate from Albany that takes away choices that should be available. There are a lot of people in the North Country who use firewood for heating, and this bill would be a step in the direction of taking that option, and other options, away as well. It would be beneficial to make electricity more affordable to increase the attraction to live in New York State. A lot of electricity that would supply this mandate is produced by fossil fuel burning plants and the electricity that will be needed would not be able to be supplied in the clean way that they want to achieve.

Mr. Denesha asked to be added as a co-sponsor to this resolution.

**WHEREAS**, Resolution No. 136-2022 authorized a contract with Beardsley Design Associates to prepare architectural and schematic design along with the bid documents for the anticipated capital renovation project in the Public Safety Complex, and

**WHEREAS**, the draft of design has been shared and reviewed by the Buildings and Grounds Committee and provided to the Board of Legislators at the March Operations Meeting with an overview of the Project, and

**WHEREAS**, the Project is nearing the bidding and construction phase and the scope of the Project will require the relocation of County staff for work to be completed, and

**WHEREAS,** Resolution No. 205-2020 authorized the Chair to sign a lease with the Workforce Development Board for approximately 6,990 square feet of space at the Human Services Center for the One Stop Career Center for the term July 1, 2020 through June 30, 2025, and

**WHEREAS,** space contained in the aforementioned Lease is available on a temporary basis for the relocation of County staff displaced by the Public Safety Complex Project, through a sublease arrangement between the Workforce Development Board and the County, and

**WHEREAS,** the amount of space required by the County through the potential sublease agreement at the One-Stop Career Center totals approximately 622 square feet on the first floor of the Human Services Center, 80 State Highway 310, Canton, New York, and

**WHEREAS**, the term of the agreement will be for one (1) year, from July 1, 2023 through June 30, 2024, at a rental rate of \$18.11 per square foot (BG619974 43007 PSC),

RESOLUTION URGING THE GOVERNOR TO VETO
NEW YORK STATE ASSEMBLY BILL A.4282B AND SENATE BILL S.3505B,
"AN ACT TO AMEND THE TOWN LAW, THE VILLAGE LAW, THE COUNTY LAW,
AND THE MUNICIPAL HOME RULE LAW, IN RELATION TO MOVING CERTAIN
ELECTIONS TO EVEN-NUMBERED YEARS"

Co-Sponsored by Mr. Hull, District 8 and Ms. Curran, District 15

**WHEREAS**, the Board of Legislators believes that increasing participation in the election process and reducing costs of government operations is good for our republic, and

- WHEREAS, during the 2023 legislative session, Assembly Member Amy Paulin and State Senator James Skoufis reintroduced legislation that would move local elections to even-number years, and
- **WHEREAS,** versions of this legislation were introduced in previous years and failed to reach the floor for a vote due to lack of support, and
- **WHEREAS**, after the 2022 session concluded, the bill sponsor indicated that hearings would be held on the proposal through the Election Committee process; however, there were no hearings held, and
- **WHEREAS**, legislation passed in the middle of the night on the last days of the legislative session is counterintuitive to the idea of an open and transparent government, and
- **WHEREAS,** local municipalities have had the ability to change their elections to evennumber years for decades, and chose not to do so, and
- **WHEREAS**, establishing the schedule of local elections is the right of the local government, and has been for more than one hundred years, and
- WHEREAS, this legislation would take over Home Rule powers reserved by local governments and protected by the Constitution of the State of New York, raising questions of legality and constitutional authority, and
- **WHEREAS,** the Sponsor of the Assembly Bill indicated that no messages of support have been received for this proposal from any of the 57 Counties and 933 Towns across New York State, and
- **WHEREAS,** the legislation excludes more than half of all New Yorkers who vote in cities and villages from the changes to election law, creating an inequity among New York voters, and
- **WHEREAS**, the proposed legislation circumvented the legislative committee process during this session, limiting public input and understanding of the impacts, and
- **WHEREAS**, there has been no financial analysis or operational analysis of the impacts on local Boards of Elections, and
- WHEREAS, there are concerns that the current election and ballot counting technology would not be able to adequately meet the demands of the significantly increased ballot size, and
- **WHEREAS**, this legislation has the potential to create confusion amongst voters in towns and counties across New York State, and

WHEREAS, separating the elections affords voters more time and focus to better understand important local issues and provides candidates the appropriate platforms to explain their stance on issues without having to compete against national and state level campaigns, and

**WHEREAS,** moving local elections to even-numbered years would increase the cost of campaigns for local office potentially reducing the number of candidates willing to invest funds into their own campaign due to the cost of media increases to compete with national and state level campaign advertisements, and

**WHEREAS,** there are significant legal and constitutional questions regarding the legality of this measure that have not been adequately addressed,

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Legislators urges the the Governor to veto New York State Assembly Bill A.4282B and Senate Bill S.3505B, "An Act to Amend the Town Law, the Village Law, the County Law, and the Municipal Home Rule Law, in Relation to Moving Certain Elections to Even-Numbered Years", and

**BE IT FURTHER RESOLVED** that certified copies of this resolution be forwarded to Governor Kathy Hochul; Senator Mark Walczyk; Senator Dan Stec; Assemblyman Ken Blankenbush; and Assemblyman Scott Gray.

\*\*\*

Mr. Lightfoot moved to adopt Resolution No. 254-2023, seconded by Mr. Burke, Mr. Gennett, Mr. Hull, Ms. Curran, Mr. Perkins, Mr. Webster.

Mr. Lightfoot said no hearings were ever held regarding this legislation as it was passed in the middle of the night prior to the last day of the legislative session. That does not give a lot of time to review the bill or know what the ramifications might be. He said municipalities have had the ability to change the years from odd to even for decades and they have not done so. Establishing local elections is the right of local government, not the State, and no messages of support have been received for this proposal from any of the 57 counties or 933 towns across the State of New York.

Mr. Reagen said by changing local elections to even years, discussion about issues in local towns and communities will be lost in the greater debates going on in State and National levels. If you mix the local elections in with the presidential and congressional elections, discussion on local levels will not be noticed and will be drowned out by the larger elections. He asked his colleagues to vote yes to this resolution and send a message to Albany to stay out of local elections.

Ms. Haggard said she spoke with the County Board of Elections and she will support this resolution.

Mr. Hull recognized the County Attorney to speak to the potential impacts and future concerns.

Mr. Hull and Ms. Curran asked to be added as co-sponsors to this resolution.

Motion carried unanimously by a voice vote with fifteen (15) yes votes.

#### **OLD/NEW BUSINESS:**

Ms. Curran said the County has a hard time taking care of many medical problems in our communities, and to take on additional people by providing migrant housing is not feasible when our own citizens cannot be provided for. On another topic, she said the drug raid last week shows that there is psilocybin, which is a hallucinogenic, in our communities and this concerns her. She hopes the County can educate the public on the dangers of these drugs.
