6. COUNTY ADMINISTRATOR'S REPORT

Ms. Doyle said eleven (11) vacancies were presented tonight.

Ms. Doyle said she was excited to announce the launch of the new County website on July 8th. In August of 2019, the Board approved \$35,000 for a new website and, to date, \$29,807.60 was spent. There is an additional \$5,950 pro-rated for maintenance and support. The Director of Governmental Services, Michael Cunningham and Assistant County Administrator, Dylan Soper, gave an overview of the new website.

The burn ban has been extended for an additional five (5) days.

There have been changes associated with the enforcement of COVID-19. To date, there have been 367 complaints submitted through the New York State On-Call. County Attorney Button said new guidelines were put into place last week, and he described the emergency regulations that were issued.

Precautions have been put into place at the Social Services Department so supervised visitation can begin this week. Keith Zimmerman has begun assisting at Social Services until a commissioner is appointed and in place. Ms. Doyle said the search committee for the Commissioner of Social Services position has selected a candidate. Cynthia Ackerman will be considered at the August Full Board Meeting, and if the resolution is adopted Ms. Ackerman will resign from The Arc of Jefferson and St. Lawrence Counties and begin work at the County no later than August 17th.

The second quarter financial update will be provided at the Finance Committee. A resolution will be included on Finance regarding costs associated with court-ordered services at NYS operated inpatient facilities. Also to be included on Finance will be a resolution extending the authorization to impose an additional one percent of sales and compensating use taxes.

County Treasurer Cole, said the final results of the second quarter sales tax is better than expected. The second quarter sales tax with the AIM adjustment shows a 5.95 percent reduction or roughly \$891,000. Ms. Cole said that means we are 2.94 percent under last year's sales tax which is amazing because this quarter is our COVID quarter. The year-to-date numbers look even better as the County had a great first quarter.

Budget projection entries for 2020 and 2021 are underway. Ms. Doyle will share the budget review schedule on google drive and all Legislators are invited to attend any department reviews they wish.

The modifications to accomplish social distancing in the Canton offices are complete with other outpost offices being completed soon.
