A. Motion carried unanimously by a roll call vote with fifteen (15) yes votes.

Ms. Haggard moved to remove the first whereas from the resolution, seconded by Mr. Burke, and carried by a voice vote with fourteen (14) yes votes, and one (1) no votes (Lightfoot).

Amended resolution carried unanimously by a roll call vote with fifteen (15) yes votes.

Mr. Arquiett left the zoom meeting at 8:16 p.m. due to the loss of power at his residence.

Mr. Arquiett returned to the meeting at 8:38 p.m.

Mr. Perkins said he was not able to log into the DANC web mapping portal on the new County website. Ms. Doyle said she will check into that.

Mr. Burke said he would like a status report regarding the Department of Social Services and staffing. He is requesting the criteria for which children are placed in foster care, the process, and the staffing needed to execute the process. He said in 2015 there were 155 children in foster care and the number today is 320 children in care. Mr. Burke said at staffing in the Legal Department of Social Services is at fifty percent (50%) and that creates great challenges. He wants to know that the process the County has in place regarding the safety of children are secure and safe. Children are removed from their homes and placed in care due to imminent danger, and as the numbers increase he wants to know the readiness of the County and the outlook at this point and time.

Mr. Denesha said he is still waiting on information regarding citizens who are unable to pay the installments on their tax bills. He said he asked the County Treasurer to report on how many people are affected by this and the impact of citizens not being able to pay their installments when the tax collector was not available during the pandemic. He know of some people who have incurred penalties due to no fault of their own. He said that if anyone was unable to pay their taxes due to COVID, the County should not assess any penalties or fines.

Mr. Lightfoot moved to go into Executive Session at 9:12 p.m., to discuss negotiations, litigation, personnel, and appointments, seconded by Mr. Forsythe, and Ms. Curran, and carried unanimously by a voice vote with fifteen (15) yes votes.
