WHEREAS, St. Lawrence County submitted a 2021-2023 Federal Transit Administration Formula Grant for Rural Areas to continue its public transportation services, and

WHEREAS, the intent of the Program is to expand access to public transit in areas that are not serviced by a bus route, or in areas where bus service is not cost-effective, and

WHEREAS, if awarded, the County would have up to five (5) years to contract with third-party vendors to design and complete the project,

SETTING A DATE FOR A PUBLIC HEARING ON PROPOSED LOCAL LAW G (NO.) FOR THE YEAR 2024, AMENDING LOCAL LAW 1 FOR THE YEAR 2023, “ALLOWING 12 AND 13 YEAR OLD LICENSED HUNTERS TO HUNT DEER WITH A FIREARM OR CROSSBOW DURING HUNTING SEASON WITH THE SUPERVISION OF AN ADULT LICENSED HUNTER”

Co-Sponsored by Mr. Forsythe, District 2 and Mr. Sheridan, District 4

WHEREAS, in 2021 the New York State Legislature as a part of the enacted 2021-2022 New York State Budget, adopted a temporary program, allowing the opportunity for young hunters, ages 12 and 13, to hunt deer with firearms and crossbow through 2023 in accordance with Environment Conservation Law § 11-0935, and

WHEREAS, pursuant to ECL § 11-0935, should a locality wish to permit 12 and 13 year olds to participate in the new hunting opportunities, the locality must pass a local law to opt into the program, and, in doing so, notify the New York State Department of Environmental Conservation (NYS DEC) to be added to a map of localities who have passed this local law, and

WHEREAS, on June 7, 2021, by Resolution No. 168-2021, St. Lawrence County opted into the program and adopted Local Law B, for the Year 2021 allowing 12 and 13 year old licensed hunters to hunt deer with a firearm or crossbow during hunting season with the supervision of an adult licensed hunter, and

WHEREAS, on February 1, the Department of Environmental Conservation (DEC) released a report affirming that the youth hunting pilot program had been beneficial to thousands of families across the State with more than 1,800 deer harvest reports being submitted by youth hunters, and

WHEREAS, the DEC conducted a post-hunting survey that found 82% of youth hunters and 87% of their adult mentors were moderately or greatly satisfied with their youth big game hunting experience, and additionally no hunting-related shooting incidents, violations, or license revocations involving 12 and 13 year old hunters occurred during the first two (2) years of the pilot program, and

WHEREAS, as part of the enacted 2023-2024 budget, New York State extended the authorization for the deer hunting pilot program from December 31, 2023 to December 31, 2025, and

WHEREAS, the law requires that a Local Law adoption be preceded by a public hearing,

NOW, THEREFORE, BE IT RESOLVED that a public hearing on proposed Local Law G (No. __) for the Year 2024 will be held on Monday, October 7, 2024, at 5:50 p.m. in the Legislative Chambers.

PROPOSED LOCAL LAW G (NO. _) FOR THE YEAR 2024, AMENDING LOCAL LAW 1 FOR THE YEAR 2023, “ALLOWING 12 AND 13 YEAR OLD LICENSED HUNTERS TO HUNT DEER WITH A FIREARM OR CROSSBOW DURING HUNTING SEASON WITH THE SUPERVISION OF AN ADULT LICENSED HUNTER”

BE IT ENACTED by the Board of Legislators of the County of St. Lawrence as follows:

The County hereby amends Local Law 1 for the Year 2023, a local law allowing 12 and 13 year old licensed hunters to hunt deer with a firearm or crossbow during hunting season with the supervision of an adult licensed hunter, specifically, **Section 1.**, omitting “through 2025”, to now state as follows:

Section 1. Pursuant to Environmental Conservation Law, ECL 11-0935, St. Lawrence County elects to participate in the temporary program to allow for young hunters, ages twelve (12) and thirteen (13), to hunt deer with a firearm, to include rifles, shotguns, and muzzle loaded firearms or crossbow.

Section 2. This local law shall take effect immediately upon filing with the Secretary of State.

WHEREAS, when necessary, Community Services will be looking for medical provider assistance by entering into contingent agreements with Locum Tenens Staffing Agencies in order to secure a temporary provider for up to thirty-two (32) hours a week for six (6) months to provide essential services until such time permanent staffing can be pursued and secured,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes the Chair to sign an amended contract with Locum Tenens Staffing Agencies, and

BE IT FURTHER RESOLVED that the Treasurer is authorized to modify the 2024 Budget for Community Services, as follows:

**PROCLAIMING SEPTEMBER 2024 AS NATIONAL RECOVERY MONTH

WHEREAS, Recovery Month was started in September 1989 by the Substance Abuse and Mental Health Services Administration (SAMHSA) to celebrate the recovery community and highlight the importance of evidence-based treatment and recovery practices, and

WHEREAS, the term “substance-use disorder”, commonly known as addiction, is a disease of the brain and many misconceptions surrounding it have contributed to harmful stigmas that can prevent individuals from seeking the treatment they need, and

WHEREAS, by treating substance-use disorders as seriously as other medical conditions with an emphasis on prevention and treatment, people can recover, and

WHEREAS, in 2023, there were an estimated 107,000 Americans who died due to overdoses nationally, and the impact of substance-use disorders is apparent in our local community, as well, as St. Lawrence County had 153 reported overdoses with 12 fatalities in 2023, and

WHEREAS, there are millions of Americans whose lives have been transformed through recovery, and since these successes often go unnoticed by the broader population, Recovery Month provides a vehicle for everyone to celebrate these accomplishments,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators proclaim September 2024 as National Recovery Month in St. Lawrence County.

WHEREAS, on April 20, 2024, Governor Kathy Hochul signed into law the New York State 2024-2025 Budget, and

WHEREAS, the enacted budget reforms the property tax enforcement laws of New York State to bring them into compliance with a decision of the United States Supreme Court, Tyler v. Hennepin County, Minnesota, 598 U.S. 631 (2023), by providing that when tax-delinquent property is sold, any excess proceeds be returned to the former owner or owners, and where appropriate, to lienors, and

WHEREAS, the bill requires any surplus resulting from tax foreclosure sales to be distributed to the former owners and lienors, subject to claims incurred by the taxing authority for administrative costs and remediation, and

WHEREAS, as a result of the Tyler Decision and the passage of the State Budget with modifications to Article 11 of the Real Property Tax Law, the Board of Legislators adopted Local Law D (No. 4) for the Year 2024, which amended the policy regarding disposition of acquired tax delinquent parcels and the date of last redemption, and

WHEREAS, the Board of Legislators may permit redemption of tax delinquent parcels, after judgment has been obtained by the tax enforcing officer in the judicial tax foreclosure proceeding but prior to the auction, by passage of a resolution authorizing the Chair and tax enforcing entity to execute any and all documents necessary to convey the foreclosed property back into possession of the redeeming tax delinquent, and

WHEREAS, pursuant to Article 11 of the Real Property Tax Law, the St. Lawrence County Treasurer (as Tax Enforcement Officer) and the County Attorney protect the interests of the County with respect to tax delinquent parcels,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes the Chair to sign all documents necessary to convey post-judgment tax foreclosure acquired property back to the redeeming tax delinquent, upon approval of the County Attorney, and

BE IT FURTHER RESOLVED that prior owners who have made payment of delinquent taxes to redeem property acquired by St. Lawrence County in foreclosure for the Year 2024 will be paid the amount of back taxes, plus any assessed penalties, interests, and fees, upon approval of the County Treasurer.

WHEREAS, the County Attorney and Consultant, Gary Bowitch, Esq. have reviewed the proposals and recommend awarding the contract to Clean Harbors,
