WHEREAS, longevity of life is a blessing for an individual and for the community that benefits from the knowledge and experiences this individual brings to all, and

WHEREAS, the County of St. Lawrence recognizes with great respect and admiration the contributions that all people, including older adults, give to our communities, and

WHEREAS, Ronald Victor Winters, known by many as "Vic", was born on September 18, 1923, in Stockholm to his parents, Johnson and Flora (Cummings) Winters, spending his younger years growing up on the Paine Farm and attending Raquette River Elementary School until 8th grade, when they moved to Wilson Hill in Louisville, and

WHEREAS, Vic remembers life before electricity and carrying wood for the wood box, using lanterns in the barn to milk 30 cows by hand twice a day and helping his mother with chores, and

WHEREAS, he attended Massena Central High School, graduating in 1941, and began work at Alcoa's physical lab, and

WHEREAS, in February 1943, Vic was drafted into the Army, the 6th Army 24th Division 226 Military Police Company for the West Coast Ordinance, where he saw service along the coast of South America, the Philippines, New Zealand, and Guadalcanal, and after the surrender of Japan, his duty was with the Japanese Police, and

WHEREAS, during this time, Vic became an expert in rifle fire, and in February 1946 was discharged, returning to Skinnerville, NY, where he started working on a milk route with Meadow Brook Dairy, and

WHEREAS, Vic met and fell in love with Anna Grace Peterson, and they were married at Grace's home on January 4, 1947, at the Pleasant Valley Farm, raising five children: Mike, Bruce, Wayne, Judy, and

Lisa, and

WHEREAS, known to his family, friends, and community as a very hardworking, determined, kind, and loving family man, Vic is revered as someone who is dedicated to family and known for his strong work ethics, working at Alcoa and Reynolds and running a family farm in Buckton, and even building a retirement home and two-story pole barn later in life,

WHEREAS, he was a member of several organizations, including serving on the Board of Education for St. Lawrence Central School District, Stockholm Land Use Committee, being a faithful and active member of the Buckton Methodist Church, and a Trustee and President of the Union Cemetery Association, and

WHEREAS, full and final settlement under the Workers' Compensation Law, closes a file permanently, resolving both the medical and indemnity portions of a claim, and

WHEREAS, 2024 has seen an increase from 2023 in the number of cases resolved by way of full and final settlement, and

WHEREAS, in some cases claims may not be ready for a full and final settlement but are eligible for a scheduled loss of use, and

WHEREAS, under New York Workers' Compensation Law, a Schedule Loss of Use Award may be made when a claimant has reached maximum medical improvement and the body part(s) of a claimant have a permanent loss of use as a result of their work-related injury, and

WHEREAS, under a Schedule Loss of Use Award, compensation is limited to a certain number of weeks based on the body part and severity of the disability, according to a schedule set by law, and

WHEREAS, these Settlements and Schedule Loss of Use Awards, which have increased significantly since 2021, has created a deficit in the Benefits and Awards Account which also covers the medical and indemnity payments of the claimant, and

WHEREAS, County Law, Article 7, Sections 363 and 366, allows the Board of Legislators to amend the budget to shift funds between accounts where there exists an excess in some accounts and a deficit in others, and

WHEREAS, it will be necessary to transfer funds from the Self-Insurance Plan Fund Balance, by increasing the appropriated fund balance to support the additional scheduled loss of use awards, as they come due,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes the Treasurer to modify the 2024 Budget for the County Attorney's Office for the Self-Insurance Fund due to increased costs in Scheduled Loss of Use Awards, as follows:

WHEREAS, in August of 2015, the Vacancy Review Committee was reestablished and assigned the role of evaluating positions within St. Lawrence County Government where Department Heads are requesting positions be abolished, created, and/or filled, and

WHEREAS, since 2016, the County Administrator has been providing the Board of Legislators with an annual summary of the actions of the Vacancy Review Committee and made recommendations for changes to be considered by the Board of Legislators to improve the efficiency of the Committee and County Staff as a whole, and

WHEREAS, the work of the Committee has held its value, including better working knowledge by Legislators of the roles and responsibilities of positions in departments and the Board of Legislators has benefited from the ongoing information provided about the annual vacancies (approximately 160), the average immediate fill rate (above ninety 90% percent), the summaries by departments, ultimately the understanding of the challenges presented to the County if positions are not filled, and

WHEREAS, one of the recommendations made by the Administrator allowed her to fill positions that had been filled for less than a year, to create and fill part-time and transitional positions, and that authority has been utilized carefully, benefiting the departments by expediting the process to fill positions, and

WHEREAS, there is a request to dissolve the Vacancy Review Committee and vest the County Administrator with the necessary authority to fill budgeted positions, and continue with the preexisting authority granted to her, and

WHEREAS, for any positions requested to be created, the process would require consideration and approval by the Board of Legislators,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes the Dissolution of the Vacancy Review Committee and delegates the authority to fill and abolish positions the County Administrator, and

BE IT FURTHER RESOLVED that the authority to create full-time positions will remain with the Board of Legislators for review and approval.

ADOPTING LOCAL LAW H (NO.) FOR THE YEAR 2024 “TAX CAP OVERRIDE FOR FY 2025”

Section 1. TITLE OF THE LOCAL LAW

This Local Law shall be entitled “Tax Cap Override for FY 2025.”

Section 2. AUTHORIZATION

For fiscal year 2025, the County of St. Lawrence shall override the real property tax levy limit established by Chapter 97 of the Laws of 2011 of the State of New York and may adopt a budget requiring a tax levy that is greater than such tax levy limit.

Section 3. VOTE REQUIREMENT

This local law is adopted pursuant to subdivision 5 of the General Municipal Law § 3-C, which expressly authorizes the County Board of Legislators to override the tax levy limit by the adoption of a local law

approved by vote of sixty percent (60%) of the Board.

Section 4. PURPOSE

The purpose of this local law is to permit the override of the limit on the amount of real property taxes that may be levied by the County of St. Lawrence, and to allow the County to adopt a county budget for the fiscal year 2025 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-C.

Section 5. DEFINITION

Tax Cap Override for FY 2025 - The County Board of Legislators, County of St. Lawrence, is hereby authorized to adopt a budget for FY 2025 that requires a real property tax levy in excess of the amount otherwise proscribed in General Municipal Law § 3-C.

Section 6. SUPERSESSON

Pursuant to the powers granted by the Municipal Home Rule, this Local Law supersedes all provisions of any other laws in the County of St. Lawrence, in so far as such statutes are inconsistent with this Local Law and any other laws or regulations of the County of St. Lawrence are superseded to the extent necessary to give this Local Law full force and effect. All other provisions shall remain the same.

Section 7. SEVERABILITY

Each separate provision of this Local Law shall be deemed independent of all other provisions therein, and if any provisions shall be deemed or declared invalid, all other provisions hereof shall remain valid and enforceable.

Section 8. EFFECTIVE DATE

This Local Law shall take effect immediately upon filing in the office of the Secretary of State, in accordance with Municipal Home Rule Law § 27.

WHEREAS, pursuant to enabling legislation, St. Lawrence County adopted implementing resolutions imposing the increase of three (3%) percent to four (4%) percent effective most recently on December 1, 2023 scheduled to expire on November 30, 2025 and is requesting an extension to allow the additional one (1%) percent be collected through November 30, 2026, and

WHEREAS, traditionally a two (2) year extender was granted to counties through Home Rule Legislation, however in 2017, New York State added an additional year to the extension, making the extension

effective for a three (3) year period, and

WHEREAS, the addition of a year on the extension was extremely helpful for fiscal planning in St. Lawrence County and if permanency is not considered, as a part of the review, in 2025, an additional three years would be the request of the County, and

WHEREAS, New York State continues to impose mandates that have financial consequences, which include but are not limited to Medicaid, special education and preschool programming, and retirement costs that places unnecessary strain on county resources, and

WHEREAS, due to the State-imposed financial mandates and the current state of the economy, it is necessary for the County to continue to seek permission to collect the additional one (1%) percent tax pursuant to Tax Law § 1210, and

WHEREAS, it is the request of the St. Lawrence County Board of Legislators that the sales tax rate be extended to provide for the four (4%) percent to be collected,

NOW, THEREFORE, BE IT RESOLVED that the St. Lawrence County Board of Legislators hereby requests the New York State Legislature and the New York State Governor adopt legislation to permit Home Rule for St. Lawrence County to extend the sales tax rate, as previously authorized, pursuant to Tax Law § 1210 and Tax Law § 1224 from three (3%) percent to four (4%) percent be extended for an additional period continuing at least until November 30, 2026, and

**AUTHORIZING A CHANGE ORDER WITH MOTOROLA SOLUTIONS, INC. FOR THE
ADDITION OF GEO-REDUNDANT PRIME EQUIPMENT AND SERVICES AT
MASSENA AND WHITE HILL SITES**

WHEREAS, Resolution No. 432-2022 authorized a contract with Motorola Solutions, Inc. for the purchase of public safety communications equipment, software, and applicable maintenance services, and authorized a lease purchase for equipment, and

WHEREAS, the successful vendor, Motorola Solutions, has recommended the County add a level of redundancy to the system through a geo-redundant prime, which is a strategy that involves spreading critical infrastructure, like servers, across multiple data centers in different locations, so if one location fails the system can continue to operate without interruption by switching to another location, and

WHEREAS, virtual Geo-Redundant Prime Site solutions for the North and South Cells will provide additional redundancy to the system, and the Prime Site is responsible for providing call processing, channel assignments, synchronization of transmissions, and comparison of received signals within the simulcast network, and

WHEREAS, the cost of the original contract was \$12,150,000, and including the Geo-Redundant Prime System equipment and deployment would add \$766,405 to the contract to be funded by FY24 (X2Z36402 25000 SICG), totaling \$12,916,405, and

WHEREAS, the original maintenance contract cost was \$4,109,998, and with the Geo-Redundant Prime Maintenance add-on at a cost of \$623,329, the new maintenance contract cost is \$4,733,327, and this change order shall increase the Radio Project Contract price by \$1,389,734 and will coincide with the original ten (10) year contract with maintenance years 4-10 estimated to begin in 2028 to be billed annually, in advance,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes a change order for the addition of Geo-Redundant Prime Equipment and Services at the Massena and White Hill Sites, upon approval of the County Attorney.

WHEREAS, following the completion of a boundary line survey of land already owned by Birchwood Apartments, LLC, the Birchwood Survey identified a small parcels of land that lie between the Birchwood parcel and Keener Road, and

WHEREAS, Birchwood Apartments, LLC has inquired as to the willingness of the County to sell the parcel with the understanding that the County has no immediate plans for this area and the land is unneeded for highway purposes, and

WHEREAS, Birchwood Apartments, LLC has offered five hundred dollars and no cents (\$500.00) to acquire said parcel to provide the necessary land area to accommodate a portion of the storm water detention pond for the development of a commercial retail store on the adjacent 1.5 acre parcel 76.076-1-4,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes the transfer of a segment of property to Birchwood Apartments, LLC, in the Town of Potsdam, and

BE IT FURTHER RESOLVED that the Chair is authorized to execute all documents necessary to convey a segment of property to Birchwood Apartments, LLC, known as the Lenora B. Dorothy Transfer of Book 178, Liber 995, upon approval of the County Attorney.

WHEREAS, the Local Government Task Force (herein “LGTF”), being a group of municipalities and school districts including the Town of Louisville, the Town and Village of Massena, the Town and Village of Waddington, the County of St. Lawrence, the Madrid-Waddington Central School District and the Massena Central School District have engaged with NYPA and negotiated an agreement pursuant to the 2002 RSA and the ten-year review process outlined in the 2002 RSA, and

WHEREAS, the LGTF has approved the tentative agreement with NYPA, and

WHEREAS, St. Lawrence County desires to approve and ratify this tentative agreement subject to changes as recommended by the County Attorney,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators approves the tentative agreement between the Local Government Task Force and New York State Power Authority, and

BE IT FURTHER RESOLVED that the Board of Legislators authorizes the Local Government Task Force to enter into the agreement on behalf of St. Lawrence County and be bound by the terms of the agreement, upon approval of the County Attorney.

BE IT FURTHER RESOLVED that the Chair is authorized to execute any documents necessary for the relicensing settlement agreement, upon approval of the County Attorney.

RESOLUTION NO. 404-2024

OPPOSING THE TEN YEAR FEDERAL ENERGY REGULATORY COMMISSION RELICENSING AGREEMENT BETWEEN THE LOCAL GOVERNMENT TASK FORCE AND THE NEW YORK POWER AUTHORITY

WHEREAS, in 1920, Congress passed the Federal Water Power Act, which gave the Federal Power Commission (FPC), the Federal Energy Regulatory Commission's (FERC) predecessor, its original authority to license and regulate non-federal hydropower projects, and

WHEREAS, as Congress expanded the regulatory authority of the FPC, the Federal Water Power Act ultimately became Part I of the Federal Power Act (FPA), and

WHEREAS, Part I of the FPA has been amended by subsequent statutes including the Electric Consumers Protection Act of 1986, the Energy Policy Act of 1992, the Hydropower Regulatory Efficiency Act of 2013, and the America's Water Infrastructure Act of 2018, and

WHEREAS, FERC relies on these authorities to carry out its hydropower responsibilities, including: the issuance of preliminary permits; determinations regarding qualifying conduit facilities; the issuance of licenses for the construction and operation of new projects; the issuance of relicenses for existing projects; the investigation and assessment of headwater benefits; and the oversight of all ongoing project operations, including dam safety and security inspections, public safety, and environmental monitoring, and

WHEREAS, St. Lawrence County is a signatory to the FERC Relicensing Settlement Agreement dated the 22nd day of February, 2002 (the "2002 RSA") with the Power Authority of the State of New York (herein "NYPA"), and

WHEREAS, the 2002 RSA contains a provision providing for a review of the terms of the RSA every ten (10) years during the term of the 2002 RSA to address unforeseen matters that were not contemplated in the 2002 RSA, and

WHEREAS, the Local Government Task Force (herein "LGTF"), being a group of municipalities and school districts including the Town of Louisville, the Town and Village of Massena, the Town and Village of Waddington, the County of St. Lawrence, the Madrid-Waddington Central School District and the Massena Central School District has engaged with NYPA and negotiated an agreement pursuant to the 2002 RSA and the ten-year review process outlined in the 2002 RSA, and

WHEREAS, while the other communities received various forms of consideration in the proposed agreement, St. Lawrence County, as a member of the LGTF, was not provided the opportunity to receive provision for security and safety on the St. Lawrence River, and

WHEREAS, the County objects to the terms of the current relicensing agreement and believes support from our various State and Federal representatives may assist in taking a closer look at the equities in the agreement,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes the Board of

Legislators opposes the ten-year Federal Energy Regulatory Commission Re-Licensing Agreement between the Local Government Task Force and the New York Power Authority, and

BE IT FURTHER RESOLVED that the Board of Legislators objects to the ratification of the FERC Re-Licensing Agreement with the St. Lawrence County LGTF, and

BE IT FURTHER RESOLVED the Board of Legislators calls upon our State and Federal representatives to assist in securing an agreement that includes provision for the County, in order to safeguard the interests on those river communities not included in the LGTF, but are equally impacted by NYPA's operations, and

BE IT FURTHER RESOLVED that certified copies of this resolution be forwarded to Governor Kathy Hochul, Senator Charles Schumer, Senator Kirsten Gillibrand, Congresswoman Elise Stefanik, Assemblyman Scott Gray, Senator Mark Walczyk, Assemblyman Ken Blankenbush, and Senator Dan Stec.

WHEREAS, the Board of Legislators appropriated a portion of the American Rescue Plan Act (ARPA) toward this effort and the work on that Project has been completed, the funds have been exhausted, and there are still trees to be removed, and

WHEREAS, in 2023, the County Administrator budgeted \$200K in targeted contingency to continue the work that was started with the ARPA Funds, and

WHEREAS, the Soil & Conservation District Office has competently administered the Tree Removal Project under the ARPA Funds and would continue the work of tree removal with the appropriated funds, and

WHEREAS, the District has solicited bids for the next phase of tree removal and recommends moving

forward to expedite the removal of hazard trees, and

WHEREAS, the County Administrator supports the recommendation of the District and would request the funds that were not utilized in 2023 be appropriated out of fund balance and the 2024 appropriations be provided along with an additional \$48,795 to complete the next phase of the Tree Removal Project,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes the Treasurer to modify the 2024 Budget for the County Administrator’s Office for removal of hazard trees in St. Lawrence County, as follows:
