## Official Absentee Ballot for the General Election - November 5, 2024

- Instructions

  1. Mark the oval to the left of the name of your choice.

  2. To vote for a condidate of the name of your choice.
- To vote for a candidate whose name is not printed on the ballot, print the name clearly in the box labeled "Write-In". staying within the box.
- 3. Any mark or writing outside the spaces provided for voting may void the entire ballot.
- 4. To vote on a question or proposal, mark the oval below your choice.

## County of St. Lawrence

- You have a right to a replacement ballot. If you make a mistake or want to change your vote, call the County Board of Elections for instructions on how to obtain a new ballot.
- 6. The number of choices is listed for each contest.
- Do not mark the ballot for more candidates than allowed. If you do, your vote in that contest will not count.
- To be counted, absentee ballots returned by mail must be postmarked by the day of the election and be received by the County Board of Elections no later than 7 days after election day.
- After marking the ballot, fold such ballot and enclose it in the envelope bearing the voter's statement, and seal the envelope.
- 10. Fill in properly the blanks in the statement and sign your name.
- 11. Enclose the sealed envelope bearing the statement in the envelope addressed to the County Board of Elections and mail promptly.
