AUTHORIZING THE CHAIR TO SIGN THE 2023 RESOURCE ALLOCATION PLAN SIGNATURE PAGE AND SIGN CONTRACTS WITH VARIOUS ORGANIZATIONS FOR YOUTH DEVELOPMENT GRANT PROGRAMS

WHEREAS, the Office of Children and Family Services (OCFS) requires that the Youth Bureau submit a Resource Allocation Plan (RAP) Signature Page that certifies approval of the program and grant contracts for the 2023 Youth Development Program year, and

WHEREAS, signing the RAP Signature Page will qualify the County for State reimbursement in the 2023 Program Year, and

WHEREAS, the Office of Children and Family Services (OCFS) has made RAP Funds available to provide Youth Development Programs (YDP), and

WHEREAS, the amount allocated to the County in 2023 for Youth Development Programs is \$79,842 (Y4073204 46000) with \$11,597 allocated for administration, \$1,500 for workshops, and \$19,300 for advocacy and training, and

WHEREAS, OCFS will reimburse St. Lawrence County for contract and county agency program expenditures, and

WHEREAS, the Youth Bureau shall retain the overall responsibility to release the Request for Proposal (RFP), plan, provide fiscal/grants management, technical assistance, audit claims, monitor, and evaluate all programs approved in the 2023 RAP,

WHEREAS, various agencies have submitted an RFP for YDP Funding through the Youth Bureau,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes the Chair to sign the 2023 Resource Allocation Plan signature page, and

BE IT FURTHER RESOLVED that the Chair is authorized to sign contracts with various organizations for Youth Development Grant Programs, upon approval of the County Attorney, as follows:

SUPPORTING THE APPLICATION OF THE DEVELOPMENT AUTHORITY OF THE NORTH COUNTRY (DANC) FOR THE 2023 CATALYST PROGRAM AND COMMITTING MATCHING FUNDS TO THE NORTHERN BORDER REGIONAL COMMISSION

WHEREAS, the Board of Legislators continues to advocate for the expansion of and accessibility to broadband services throughout the County, and on October 4, 2022, a Broadband Committee was appointed that includes DANC, BOCES, and the St. Lawrence County IDA to address issues of broadband access within the County, and

WHEREAS, on May 2, 2022, Resolution No. 181-2022 authorized the acceptance of the ARPA Committee recommendations for the American Rescue Plan Act (ARPA) Funds, which included \$3M allocated for Broadband Development and Installation, and

WHEREAS, most recently, Resolution No. 145-2023 authorized signing contracts for the purpose of funding broadband development and installation for sixteen (16) projects from two (2) internet service providers, with the potential to provide high speed internet service to approximately 610 additional residences in St. Lawrence County, and

WHEREAS, the Northern Border Regional Commission is a partnership between the federal government and the States of Maine, New Hampshire, New York, and Vermont whose mission it is to fund economic development and infrastructure projects throughout designated counties in its four-state service area, and

WHEREAS, Development Authority of the North Country (DANC) serves the common interests of Jefferson, Lewis, and St. Lawrence counties and owns and operates a number of revenue-based infrastructure facilities including an extensive fiber optic network, and

WHEREAS, through a competitive process, DANC is preparing a regional application for the expansion of broadband infrastructure that includes St. Lawrence County, and this requires matching funds,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators supports the application of the Development Authority of the North Country (DANC) for the 2023 Catalyst Program and commits matching funds to the Northern Border Regional Commission, and

BE IT FURTHER RESOLVED that the Board of Legislators commits up to \$250,000 in local funds as a portion of the required matching funds, and

BE IT FURTHER RESOLVED that the Board of Legislators authorizes the Chair to sign any documentation necessary for the application and administration of this project.
