Presentation by North Star Health Alliance – See attached for presentation by Dominic Doldo. Presentation followed slides closely. Important notes: Not interested in 911, not planning on pulling employees from current system, hope to "home grow" own from the health system. Trying to provide consistent service for interfacility transfers and meet needs of the hospitals and their patients.

Responses to Q&A:

- -Application for CON will <u>NOT</u> be a county wide <u>CON</u>, will list the addresses of their facilities as operating territory. Personally assured by D Doldo, may or may not include their rural health clinics.
- -Short response time was due to REMAC meeting timeline. Timeline is now being pushed back a bit to file, hopefully within the next two weeks.
- -At this point not planning on including the other area hospitals in the CON application, but is speaking with Rochester Regional management to possibly include those facilities.
- -Planning on using EMT as driver with paramedic, but will pull from other staffing in the hospital if needed. Willing to use staffing agencies as needed.
- -Hoping to strengthen EMS career path through hospital based EMS.
- -May send transports double BLS with RN if needed.

SEMSCO - Vital signs held this weekend. J Moore awarded NYS RN of Excellence.

REMSCO/REMAC – Meeting was cancelled, next will be held in November.
