Reports:

Risk Management -Jody Wenzel has been working doing fire departments. Flooding – the county has gotten notice of possible flooding. Staffing – still at a low Fit testing machines – 2 new machines added, both have ID program installed to make it easier for chiefs to get ID's printed.
