Local leaders, residents, and stakeholders, such as public housing authorities, cities, schools, police, business owners, nonprofits, and private developers, come together to create and

implement a plan that revitalizes distressed HUD housing and addresses the challenges in the surrounding neighborhood. The program helps communities transform neighborhoods by redeveloping severely distressed public and/or HUD-assisted housing and catalyzing critical improvements in the neighborhood, including vacant property, housing, businesses, services and schools. The purpose of the FMPP is to increase domestic consumption of, and access to, locally and regionally produced agricultural products, and to develop new market opportunities for farm and ranch operations serving local markets by developing, improving, expanding, and providing outreach, training, and technical assistance to, or assisting in the development, improvement, and expansion of, domestic farmers markets, roadside stands, community-supported agriculture programs, agritourism activities, and other direct producer-to-consumer market opportunities. The minimum FY 2019 FMPP award per grant is \$50,000, and the maximum is \$500,000. A 25 percent match of total Federal funds is required. Eligible applicants include: Agricultural businesses; Agricultural cooperatives; Community Supported Agriculture (CSA) networks; CSA associations; Economic development corporations; Local governments; Nonprofit corporations; Producer networks; Producer associations; Public benefit corporations; Regional farmers' market authorities; and Tribal governments.

The LFPP offers grant funds with a 25% match to support the development and expansion of local and regional food business enterprises to increase domestic consumption of, and access to, locally and regionally produced agricultural products, and to develop new market opportunities for farm and ranch operations serving local markets. There are two types of project applications are accepted under LFPP—planning grants and implementation grants. Applicants can apply for either but will receive only one type of grant in the same grant cycle. Eligible entities may apply if they support local and regional food business enterprises that process, distribute, aggregate, or store locally or regionally produced food products. Such entities may include: Agricultural businesses and cooperatives; Producer networks and associations; Community supported agriculture networks and associations; Other agricultural business entities (for-profit groups); Nonprofit and public benefit corporations; Economic development corporations; Regional farmers' market authorities; Local and tribal governments.

- **LFPP Planning Grants** are used in the planning stages of establishing or expanding a local and regional food business enterprise. Activities can include but are not limited to market research, feasibility studies, and business planning.
- **LFPP Implementation Grants** are used to establish a new local and regional food business enterprise, or to improve or expand an existing local or regional food business enterprise. Activities can include but are not limited to training and technical assistance

for the business enterprise and/or for producers working with the business enterprise; outreach and marketing to buyers and consumers; and non-construction infrastructure improvements to business enterprise facilities or information technology systems.

The Justice and Mental Health Collaboration Program (JMHCP) supports cross-system collaboration to improve responses and outcomes for individuals with mental illnesses (MI) or co-occurring mental illness and substance abuse (CMISA) who come into contact with the justice system. This program supports officer and public safety and violence reduction through social service and other partnerships that will enhance and increase law enforcement responses to people with MI and CMISA. BJA offers three specific categories for communities to access federal funding and technical assistance:

Category 1 supports counties as they go through collaborative planning and implementation phases in improving their comprehensive response to people with mental illness that come into contact with the justice system.

**Category 2** focuses on the interaction of law enforcement and people with mental illness. Applicants to this category generally are law enforcement agencies.

Category 3 invites projects from anywhere within the criminal justice system where that system may interact with people who have mental illness. Category 3 is a fairly wide open category of funding, and applicants range from agencies such as law enforcement, prosecution, courts, corrections, and parole and probation.

For the purposes of this rebate program, the following entities are considered eligible applicants: Municipalities defined as counties, cities, towns, and villages of the State of New York or boroughs of the City of New York, pursuant to 6 NYCRR § 492-1.1(j). A total of \$300,000 is available for Clean Vehicle Rebates. Rebates of \$2,500 per vehicle will be issued toward the cost of an eligible clean vehicle with an all-battery electric range between 10 and 50 miles, and rebates of \$5,000 per vehicle will be issued toward the cost of an eligible clean vehicle with an all-battery electric range of greater than 50 miles. Eligible clean vehicles (as defined in ECL § 54-1521(1)(c) and 6 NYCRR § 492-1.1(g)) include all-electric and plug-in hybrid electric vehicles and hydrogen fuel cell vehicles that adhere to specific parameters.
