# St. Lawrence River Valley Redevelopment Agency aka RVRDA Community Development & Environmental Improvement Program

Catalyst Grant, Forest Economy Program, Timber for Transit Program

The <u>Catalyst Program</u> is designed to stimulate economic growth and inspire partnerships that improve rural economic vitality across the four-state NBRC region. NBRC encourages projects that take a creative approach to addressing an economic need or opportunity in the region, alleviate economic distress, and contribute to economic growth. Successful projects support a broad range of economic development initiatives such as, but not limited to, projects that modernize and expand access to public water and wastewater services, revitalize transportation infrastructure, establish workforce development programs and facilities, grow the outdoor recreation economy, and provide access to new childcare and healthcare facilities.

The <u>Forest Economy Program</u> is designed to support the forest-based economy, and to assist in the industry's evolution to include new technologies and viable business models across the 4-state NBRC region. The Forest Economy Program is distinct from NBRC's Catalyst funding in two important ways: it emphasizes the potential to impact the forest-based economy across the entire NBRC region, and infrastructure projects (transportation, water and wastewater, telecommunications, and energy) must directly support the forest industry.

The purpose of the <u>Timber for Transit</u> program is to advance the use of wood-based materials and composites (advanced wood materials) through applied research and demonstration projects that showcase the suitability of such materials to transportation and

transportation adjacent infrastructure. Highly competitive projects will demonstrate and widely promote the utility of high value forest products (e.g. glued laminated timber, cross laminated timber, composite materials, etc.) in transportation infrastructure and commit to enhancing climate resilience in rural communities.

Outride strives to empower people to experience the social, emotional, and cognitive benefits of cycling. They support schools and nonprofits to create and sustain cycling programs in their communities, with an emphasis on equity and inclusion.

RIDING FOR FOCUS (R4F) is a school-based rider education program. Developed as a result of our initial research findings, R4F promotes cycling as an outlet for students to improve their social, emotional, and cognitive well-being. Schools can get an R4F program via two pathways: purchasing the program, or, for public middle schools serving low-income communities, by applying for a program grant. Schools are provided with everything they need to get their 6th-8th grade students riding, including bikes, helmets, curriculum, teacher training, and an opportunity to attend our annual instructor training event at a Specialized bikes office. Not a cash grant.

#### **Community Impact Grants**

Are competitive monetary (cash) grant for general youth cycling programs and organizations i.e. racing programs, afterschool programs, trail construction, rider education, community cycling programs, etc. The organizations that will be most competitive for the community impact grant are local, small to medium sized nonprofits.

AARP seeks applications from 501(c)(3), 501(c)(4), and 501(c)(6) nonprofit organizations, and government entities for projects that benefit people, especially those age 50 and older, across three programs: Flagship Grants; Capacity-Building Microgrants; and Demonstration Grants.

Deadline: March 5, 2025

**Flagship AARP Community Challenge** grants have an average grant amount of \$10,000 to \$12,000. Nine out of 10 grants (or 92 percent) are for \$20,000 or less. In 2025, grants will not exceed \$25,000. Applications are sought in the following categories:

- Creating vibrant public places that improve open spaces, parks and access to other amenities.
- Delivering a range of transportation and mobility options that increase connectivity, walkability, bikeability and access to public and private transit
- Supporting a range of housing options that increases the availability of accessible and affordable choices
- Increasing digital connections and enhancing digital literacy skills of residents
- Supporting community resilience through investments that improve disaster management, preparedness and mitigation for residents.

<u>Capacity-Building Microgrants</u> combine \$2,500 grants with additional resources (such as webinars, cohort learning opportunities, up to 2 hours of one-on-one coaching with leading national nonprofit organizations and AARP publications). Applications are sought in the following categories: Disaster Preparedness Training; Walk Audits; Bike Audits; and HomeFit Guide Modifications.

**Demonstration Grants** fund projects that encourage the replication of promising local efforts. Grants tend to fall between \$10,000 and \$20,000 and will not exceed \$25,000. Applications are sought in the following categories: enhancing pedestrian safety; expanding high-speed internet (broadband) access and adoption; reconnecting communities divided by infrastructure; and implementing housing design competitions.

The BRIC program's guiding principles include supporting communities through capability and capacity-building; encouraging and enabling innovation, including multi-hazard resilience or nature-based solutions including the use of native plants; promoting partnerships; enabling large, systems-based projects; maintaining flexibility; and providing consistency. Through these efforts communities are able to better understand disaster risk and vulnerabilities, conduct community-driven resilience, hazard mitigation planning, and design transformational projects and programs.
