INSTRUCTIONS

- 1. When the alternative veterans exemption is granted based in part on service-connected disability rating received from the United States Veterans Administration or the United States Department of Defense, evidence of continued exemption eligibility must be provided by the property owner if the disability rating increases or decreases.
2. The change in percentage of disability rating must be certified on this form (RP-458-a-Dis) and filed with the assessor prior to taxable status date in order for the exemption to be properly adjusted.
3. Taxable status date for most towns is March 1. In towns in Erie County, the taxable status date is May 1. In towns in Westchester County, the taxable status date is June 1. In Nassau County, the taxable status date for towns is January 2. Taxable status date for most villages which is January 1; however, the village clerk should be consulted to insure certainty.
